Over 40 Attend Oneida Hills UMP Meeting

Local municipal officials, recreationists, land owners, and others attended the NYS Department of Environmental Conservation's public meeting on the Oneida Hills Unit Management Plan on July 19 in Steuben. Comments from attendees included the need to prevent vandalism at old cemeteries on the state forests, how the state can increase harvesting on these lands, and the importance of maintaining and improving recreational trails throughout the area. The UMP will guide management actions for the Unit to help achieve the goals of providing healthy, sustainable and biologically diverse forest ecosystems. Grant Available for Playground Equipment

KaBOOM! is a national non-profit dedicated to saving play for America's children. Their mission is to create great playspaces through the participation and leadership of communities. KaBOOM! recently announced a new grant opportunity to increase access to playgrounds at the fraction of the cost of a new build. Joint use agreements allow local governments to partner with local school districts to open school recreation facilities to the public during non-school hours. The \$15,000 Joint Use Grants can be used to support the opening of at least four playgrounds and are available to communities with populations less than 100,000. The grants are part of Let's Play, a community partnership led by Dr. Pepper Snapple Group to get kids and families active nationwide. The St. Lawrence Eastern Lake Ontario Partnership for Invasive Species Management (SLELO PRISM) has completed several field surveys so far this season in different areas of its area (all of Tug Hill included). Those reports are available on its website at <http://www.sleloinvasives.org/field-reports/2012-field-season/>. Of particular interest are the reports on Whetstone Reservoir (no invasive species found) and Oneida Lake (including Three Mile Bay, where water chestnut was found). There has also been significant Giant Hogweed control completed this field season throughout the area.



Mohawk Valley Regional Sustainability Plan

A plan is being developed in response to Governor Cuomo's award of a Cleaner, Greener Communities (CGC) program to develop and implement smart growth plans for regional sustainability. The program is being funded by a \$1,000,000 grant through NYSERDA. There are several opportunities for individuals, companies and municipalities to get involved. The Mohawk Valley Regional Consortium is looking to populate the following working groups. The focus areas are Energy, Transportation, Waste Management, Water Management, Land Use/Livable Communities, Economic Development, Governance and Climate Change Adaptation. Based on the results of a survey that was circulated to early members of the MVR consortium we have elected to add an Agriculture/ Forestry working group as well. As the process moves along, the planning team will be looking for input from experts across a wide range of fields, as well as ideas from community residents. There will be opportunities for interested parties to contribute through public meetings and for some as members of a working group. Local Governments Facing New Fiscal Reality

State Comptroller Thomas P. DiNapoli recently issued a report on the stress of local government finances facing New York municipalities and school districts. The study found that nearly 300 local governments had deficits in 2010 or 2011 and more than 100 had inadequate cash on hand to pay their current bills. The analysis warns that some municipalities and school districts have become increasingly vulnerable to unanticipated expenses such as emergencies, mandates and unexpected spikes in the costs of goods and services. The report is based on an analysis of data from 4,000 local governments and recent audits.



Although cities seem to be most at risk – due to population loss, declining or stagnant property assessments, high poverty rates and older and decaying infrastructure – the analysis shows all local governments have been impacted by shortfalls in expected revenues since the onset of the Great Recession. All told, local governments suffered an actual decline in revenues of more than \$400 million during the recession. The result has been reduced spending on public safety, health and recreational programs, garbage collection and transportation.

DiNapoli urged local governments to institute effective multi-year financial planning processes to identify structural imbalances between revenues and expenditures, and use excess fund balances for immediate needs such as paying off debt.
