Grants Available for Water Quality Improvement Projects

The NYS Department of Environmental Conservation has announced that Round 11 of grants for Water Quality Improvements Projects is now open, with a deadline of November 8, 2013. Funding is available in the following categories:

- Non-agricultural Nonpoint Source Abatement and Control (25% match required)
- Municipal Wastewater Treatment Improvement (15% match required)
- Aquatic Habitat Restoration (25% match required)
- Municipal Separate Storm Sewer Systems (MS4s) (25% match required)

Municipalities are eligible applicants for all four categories. To be eligible to receive a grant, a project must address a documented water quality impact or threat. Information for waterbodies is available in the New York State WI/PWL, available at <http://www.dec.ny.gov/pubs/42978/html#pwl>.

Public Invited to Lake Ontario Ecosystem Forum in Oswego

The U.S. Environmental Protection Agency (USEPA), New York State Department of Environmental Conservation (DEC), and New York Sea Grant will host two forums in August about environmental issues affecting Lake Ontario and the work being done under the Lakewide Action and Management Plan (LAMP) to address these issues. Closest to Tug Hill, a public meeting will be held on Thursday, August 22 in Oswego: 6:00-8:00 p.m., Campus Center Room 132, SUNY Oswego, Oswego, NY 13126. Approximately $\frac{3}{4}$ of Tug Hill drains to Lake Ontario, with the remainder draining to the Mohawk River.

Expert presenters from NYSDEC, the U.S. Geological Survey, the NY Natural Heritage Program, key universities, and county and local watershed organizations will offer presentations on water quality in Lake Ontario, the quality of Lake Ontario beaches, the lake's food web, restoration of native fish species, research on toxic contaminants in fish, and monitoring and restoration of the lake's coastal wetlands. Lake Ontario is the 14th largest lake in the world, provides drinking water for 8 million people, and supports a multi-million dollar sportfishing industry. As part of the largest freshwater system on earth (the Great Lakes), Lake Ontario is a unique biological resource which supports special fish and wildlife species and a complex food web. The watersheds of the Lake Ontario basin cover nearly 1/3 of New York State's land area; and influence conditions in the lake, especially the areas close to shore where people have the most contact with the lake.

Lake Ontario's ecosystem is affected by nutrients and other pollutants, invasive species, and climate change. With support from the Great Lakes Restoration Initiative (GLRI) and guided by the binational LAMP, work is underway to improve water quality, reduce levels of toxic contaminants in fish, restore native fish species such as Lake Sturgeon, prevent the spread of invasive species, and improve habitat quality in the lake's coastal wetlands.

Developing Municipal Budgets

Laird Petrie from the Office of the State Comptroller (OSC) will present **Developing a Municipal Budget** at Kunsela Hall, SUNYIT, Utica on Thursday, September 5, 6:30- 8:30 p.m. Sign in starts at 6:00 p.m.. This training program is designed to assist village and town officials in developing a structurally balanced budget. Topics to be covered include:

- Key elements of the annual budget
- Budgetary responsibilities of Town and Village Officials
- Understanding fund balances
- Capital reserve account
- Tools available for assisting Town and Village officials in the budget process
- Monitoring & amending the annual budget

A question and answer period will conclude the workshop. Please register early so that Laird has time to print out a five year summary for your town based on the yearly annual reports.

Oneida Lake Boating Safety Map

If you have ever been in a boat that hit something on Oneida Lake that should not have been here, then you will be interested in the Oneida Lake Associations' new Oneida Lake Boating Safety Map. The OLA developed and published the map with the goal of increasing boating safety and saving lives. The map points out all the buoys and danger areas in the channel and along the shoreline. The map isn't going to tell you about the debris in the lake which has been plentiful this summer because of all the rain. You will still have to be on the lookout for deadhead logs and other partially submerged obstacles.

The map also includes some common sense navigation tips that bear repeating. The maps will be distributed to the public libraries, schools and village and town offices for in-house-use. A limited number will be available around the lake at marinas. The map is not for sale but it can be downloaded from OLA's web site www.oneidalakeassociation.org.
