

Commission Members Elect Officers

At their December 12 meeting Tug Hill Commission Members elected officers for the 2013-14 term. Elected unanimously were Jan Bogdanowicz from Montague as Chair; Michael Yerdon (immediate past Chair) from Redfield as Vice-Chair; and, Thomas Boxberger from Watertown as Secretary. Chair-elect Bogdanowicz commended outgoing chair Mike Yerdon on his leadership over the past four years. Mr. Bogdanowicz also outlined some of his priorities for the coming term, including collaboration and team building with state agency partners and non-governmental organizations in the Region; protecting Home Rule while advancing shared services among Tug Hill local governments; and, effective outreach to Tug Hill Legislators and State Legislators throughout the State.

All the Commission Members stressed the need to ensure that the Commission strengthens its commitment to Tug Hill communities and the economy of the region. Chair-elect Bogdanowicz emphasized the need to build the region's economy from the bottom-up while sustaining the region's rural quality of life and abundant natural resources. As a third generation Tug Hiller and Executive with a Fortune 100 business, Mr. Bogdanowicz brings a wealth of familiarity with Tug Hill and over 30 years of private sector business development experience to the helm of the Commission. He thanked his fellow Commission Members for their support and commitment to the region and looks forward to their continued work on behalf of Tug Hill.



Boonville Economic & Industrial Development Corporation Report

The Boonville Economic and Industrial Development Corporation (BEIDC) recently met at the Town and Village of Boonville offices to receive the report done by the Syracuse University Newhouse School. The research project was requested by BEIDC and was conducted by Hill Communications, a student-run public relations firm to gather information about the Boonville community in an effort to revitalize the community socially and economically. Each year the firm takes on several public relations projects and, this semester, they agreed to assist the Village of Boonville at no charge. The research project included a focus group with a SWOT exercise, an interview with a community leader, a survey completed by juniors and seniors at the Adirondack High School and a direct observation completed in the village.

Almost all of the focus group participants agreed that Boonville is good place to live. Residents enjoy the friendly atmosphere of living in a small community where people know each other. Although participant residents in the research project want to see some improvements in facilities and recreation opportunities, they want the changes to come in a gradual way and none of them wants a drastic change.

The four key areas that were identified in the report as needing renewed focus by the community in terms of marketing and promotions were:

- 1. Implementing a social media presence in the community while at the same time developing a cohesive and centralized media source for distribution to individuals and groups outside of the area.
- 2. Finding a way to integrate the youth/students of the community into events and projects that are a footprint for success going forward.
- 3. Improving the appearance of the downtown area in the village to encourage people to want to eat, shop visit, and return to Boonville.
- 4. Encouraging a stronger sense of community by sharing existing media resources and instead of "stumbling" upon each other, working together toward goals which in many cases are common.

"Hopefully this will give us some great ideas going forward and ways in which to expand our marketing and promotional plans for our community," BEIDC member Jen Shoemaker said. The meeting also provided an opportunity to touch base on the next stages of BEIDC going into 2013, as well as a time to discuss some of the positive things happening in the community already.


Regional Economic Development Council Awards

Governor Andrew M. Cuomo this week announced that \$738 million has been awarded through Round Two of the Regional Economic Development Council (REDC) initiative including: **CENTRAL NEW YORK** Top Performer Award and \$93.8 Million for 73 Projects; **NORTH COUNTRY** Top Performer Award and \$90.2 million for 82 projects; and, **MOHAWK VALLEY** \$59.7 Million for 70 Projects. There were several projects funded within and around the Tug Hill region including:

- Oswego County (CNY REDC) Central Square Central New York Raceway Park (\$2,000,000); Town of Constantia Sewer
 District Engineering Study (\$30,000); and two SUNY College of Environmental Science and Forestry projects related to
 Biotechnology and willow biomass (\$897,831).
- Jefferson County (NC REDC) Carthage Downtown Revitalization Program (\$200,000); Carthage Apartments (\$2,000,000); Creekwood Apartments Phase 2 (\$3,000,000); Town of Champion sewer line replacement engineering study (\$30,000); Village of Carthage Wastewater Engineering Study (\$30,000); and Celtic Energy Farm green energy willow project (\$470,000).
- Lewis County (NC REDC) Croghan Dam restoration (\$375,000); Lyons Falls Mill site redevelopment (1,000,000); Lewis County General Hospital Dialysis Center (\$300,000); Snow Belt Housing Gateway Project in Lowville (\$200,000); Town and Village of Turin wastewater engineering study (\$24,000); Village of Lyons Falls wastewater engineering study (\$30,000).
- Oneida County (MV REDC) Harden Furniture lean manufacturing project (\$600,000); Town of Forestport wastewater engineering study (\$30,000).

In addition, the North Country REDC had a number of regional projects funded including the Community Tourism Transformational Fund (\$2,000,000); I-81 Corridor Marketing (\$84,000); Thousand Islands Tourism Development Corporation I Love NY Fishing (\$60,000); Adirondack North Country Association "Invisible Factory" program (\$50,000); Infrastructure Fund (\$2,500,000); and, the Community Renewal Fund (\$1,000,000).

Congratulations to all the awardees and partners that helped make all these projects become funded!



Sustain Our Great Lakes Funding Available Early in New Year

The National Fish & Wildlife
Foundation (NFWF) will post a new
Request for Proposals on their website
www.sustainourgreatlakes.org on
January 3rd. In 2013, grant funding for
work in the Great Lakes basin will be
awarded in three categories: 1) habitat
restoration; 2) delisting of habitat-related
beneficial use impairments; and
3) private landowner technical
assistance. Pre-proposals will be due on
February 14, 2013.

NFWF is holding a webinar on January 15, 2013 at 11 am to learn more about the funding opportunity and the application process, see examples of
