## **Tug Hill Commission Summer Internship**

The Tug Hill Commission, in partnership with the Cooperative Tug Hill Council, is currently seeking qualified applicants for a 2017 summer internship. The intern's primary task will be to update, restructure, and improve the existing report titled Tug Hill Resource Management Plan (2006), which can be found here: http://www.tughillcouncil.com/PDFs/ResourceManagementPlan2006Update.pdf. The intern will use internet (U.S. Census, NYS Office of Real Property Services, NYS Comptroller's Office, etc.) and other sources to retrieve data and software such as Microsoft Excel for processing and analysis.

The basic qualifications and preferred experience are:

- · College student with good writing and communication skills.
- · Ability to think systemically and logically.
- · Ability to creatively solve problems.
- · Working knowledge of Microsoft Office Suite (Word, Power Point, Excel, etc).
- · Driver's License valid in New York State.
- · GIS experience is a plus.
- · Familiarity with Tug Hill region a plus.

The intern will work 37.5 hours/week starting mid-May until mid-August, at a rate of \$10/hour. Interested students should submit a cover letter and resume by March 1, 2017.

## Village of Barneveld Presents Petition to Dissolve

Another village in the Northern Oneida County Council of Governments could dissolve following the presentation of a petition by residents in the village of Barneveld.

Fifty electors signed the petition to pursue village dissolution, which was presented to the village clerk earlier this month. The law requires the petition to be signed by 20% of registered electors. The village board now has thirty days to set a referendum date, which must take place between 60 and 90 days later. The board met on February 14<sup>th</sup> and opted to tentatively set the referendum for June to provide ample time for local officials and residents to research the process and gather adequate information to guide their decisions. If the referendum passes, the village board will be required to prepare a plan within 180 days of the certification of the vote.

According to the 2010 census, there were 284 residents in the village of Barneveld. About 180 are registered electors.

If it dissolves, Barneveld would become the second village in the town of Trenton, located in northern Oneida County, to dissolve. The Village of Prospect dissolved in 2015. Also in the Tug Hill region, Altmar in Oswego County dissolved in 2013; and the village of Herrings in Jefferson County is set to dissolve March 31.

### Venerable Folks Exhibit On Display at TAUNY

A grand opening of the Venerable Folks Exhibit took place on February 11 at the Traditional Arts of Upstate New York (TAUNY) gallery in Canton. Visitors can see real Tug Hill artifacts on display along with the thematic panels that demonstrate life on Tug Hill. Pictured below are the "Living off the Land," "Community Spirit," and "Surviving Winter" compilations.

The exhibit will be on display through mid-May. Funding was provided by the St. Lawrence Arts Council, NYS Council on the Arts, NYS Tug Hill Commission, Iroquois Gas Community Grant Program, The John Ben Snow Foundation, Inc, and the Northern New York Community Foundation. ## DEC Seeking Public Input on Fish Creek Unit Management Plan for Kasoag, Klondike, Orton Hollow, and Stone Hill State Forests

The New York State Department of Environmental Conservation (DEC) is beginning the process of developing the Unit Management Plan (UMP) for 3,464 acres of State Forest lands within the Fish Creek Unit of the Tug Hill Region. The state forest UMP's being developed include Kasoag, Klondike, Orton Hollow, and Stone Hill State Forests. The lands are located in the Oswego County towns of Amboy and Williamstown. UMPs assess the natural, physical, social, and recreational resources of the landscape and provide a solid foundation for the development of long-term land management goals, objectives, and actions. The public is invited to share ideas about plan development during the scoping period, which runs from February 15 – March 15, 2017. The public is invited and encouraged to provide feedback in a number of ways.

Tuesday, February 28, 10:00 a.m. - 2:00 p.m. (snow date Tuesday, March 7)
