RACOG "Lighting" The Way

David Bradford, the ANCA Energy Circuit Rider, presented at the RACOG board meeting on January 23rd, 2018. He discussed the different options for changing lighting districts within the area over to LEDs. Should the communities decide to move forward, they have two options. They can go with utility owned light replacement or they can go with municipal owned. Each has their benefits, so the members in RACOG will be looking into their different options.

Also presenting was Jamie Rogers, the ANCA Communities Outreach Coordinator. His presentation was on the Clean Energy Communities program. A community that does four out of the 10 High Impact Actions can be designated as Clean Energy Communities, which could open up opportunities for other funding. One of the items on that list of High Impact Actions, was changing street lights over to LEDs.

Mickey Dietrich, the RACOG Circuit Rider also reported that the new RACOG website is ready to go live, which the board approved. In the next week, the new site should be moved to the www.racog.org web address. Be on the lookout for it!

State Archives Grant Applications Submitted

Commission staff assisted with applications under State Archives Local Government Records Management Improvement Fund (LGRMIF) program, working with local records management officers to develop projects in the following communities:

- The village of West Carthage requested \$9,540 to hire a consultant that will address a backlog of inactive court records, following the dissolution of their village court into the town of Champion's court.
- The town of Leyden requested \$14,428 for minor renovations to improve an inactive records storage room and to purchase fire proof filing cabinets for active use in their historic town hall.
- The village of Port Leyden, a first-time LGRMIF applicant, submitted an application for \$22,913 to remodel a portion of the village hall for inactive records storage. The climate-controlled, fire-rated room will include installation of steel shelving. The request also includes hiring a consultant to assist with an inventory, reorganization and transfer of records to the new storage room.

The 2018-2019 LGRMIF deadline was January 16th. State Archives expects to make award announcements later this year. LGRMIF information can be found here: http://www.archives.nysed.gov/grants/grants-lgrmif.shtml.



Hemlock Woolly Adelgid Workshop

shop is to strengthen early detection efforts for hemlock woolly adelgid (HWA), an invasive forest pest that kills hemlock trees. Workshop attendees will learn how to recognize the symptoms of a hemlock woolly adelgid infestation and report observations via iMapinvasives.org (www.imapinvasives.org). The draft updates will eventually be sent to the Oneida County Planning Board for 239-m review before final adoption by the town board.

NYSDEC Endorsed 4-Hour Erosion and Sediment Control Training

The Jefferson County Soil and Water Conservation District will be hosting their annual NYSDEC Endorsed 4-Hour Erosion and Sediment Control Training on Thursday, March 29, 2018. Under the NYS DEC's Stormwater Permit, all developers, contractors and subcontractors must identify at least one trained contractor from their company that will be responsible for implementation of the SWPPP, and have at least one trained contractor on site on a daily basis when soil disturbance activities are being performed.
