Great Turnout, Lively Discussion at SuperCOG Meeting

Thirty council of government members, town and village officials, Tug Hill Commission

members and staff met at the Redfield Fire Hall Wednesday, May 30 for a "SuperCOG" meeting. Held periodically, SuperCOG provides an opportunity for all five Tug Hill Councils of Governments (Cooperative Tug Hill Council, Northern Oneida County Council of Governments, North Shore Council of Governments, River Area Council of Governments, and Salmon Rivers Council of Governments) to provide updates on important projects and issues in their part of Tug Hill, and have discussion on region-wide topics.



After a brief introduction to SuperCOG by commission executive director Katie Malinowski, Cooperative Tug Hill Council (CTHC) Chairman Roger Tibbetts opened the meeting and welcomed all. Ms. Malinowski provided an overview of draft results from the 2018 Local Leaders Survey, and gave some brief updates on minimum maintenance roads, 480a, and wind proposals. Each council then had an opportunity to share items, which ranged from the addition of communities to CTHC and RACOG; various infrastructure projects including water, sewer, salt storage, and recreational trails; and website redesigns.

The floor was then open to any topics participants wanted to raise. Significant discussion ensued regarding various wind farm proposals. Other regional discussion items included three phase power upgrade needs, as well as broadband and cell phone coverage improvements underway and still needed.

State Archives Grants Awarded to Tug Hill Municipalities

Tug Hill municipalities were recently awarded grants to improve municipal records management. Applications were submitted earlier this year under the New York State Archives Local Government Records Management Improvement Fund (LGRMIF) program. Commission staff worked with the village of **Port Leyden** and the village of **West Carthage**. The village of Port Leyden was awarded \$22,913 to renovate part of the village office to create an inactive records storage room that includes steel shelving and fire-safe filing cabinets. A consultant will assist the village in inventorying and organizing the records. The village of West Carthage was awarded \$9,540 to hire a consultant that will inventory and organize inactive court records after the consolidation of the village court into the town of Champion.

The third successful LGRMIF application in the region is the **town of Turin**, awarded \$24,560 to advance their inactive records management program.

Oneida Lake Association Holds Annual Meeting

The Oneida Lake Association held its annual meeting in front of a substantial turnout of its membership at the auditorium of Gillette Road Middle School in Cicero. Agenda items included the Association's annual election of officers and directors, identification of 2018-19 goals, an update on the Oneida Lake Fish Cultural Station, the state of the Oneida Lake fishery, invasive species, and an introduction to harmful algal blooms (HABs).

Oneida Lake spans two of the counties of the Tug Hill region – Oswego and Oneida – and Oneida Lake is within the boundaries of those two counties

The fish cultural station is now able to collect enough fish for their annual hatchery operations using fewer nets than in the past, and egg yields per female are up. Walleye and smallmouth bass populations are increasing, while white perch are trending downward, and the sturgeon are doing well. Cormorant levels are up in the last two years, and the hazing program continues from mid-April through July. Quagga mussels are replacing zebra mussels in the ecosystem, but there is no overall diminution.

Regarding HABs, speaker Dr. Gregory Boyer, SUNY ESF professor and Director of the Great Lakes Research Consortium, identified six factors that support their growth (nutrients, light, warm temperatures [>60 degrees F], calm winds, seed population, and grazing); the most major human intervention possible is reduction of nutrients contributed to the lake from the watershed. New York State is currently supporting a study of HABs, with lessons learned to be applied to other impacted waterbodies. Lakes to be studied in Central New York as part of the larger twelve lake program are Owasco Lake, Skaneateles Lake, and Cayuga Lake



Citizen Science Opportunities with NYS DEC

To understand the success of the Black River Initiative, Sandy Creeks agricultural environmental management efforts, and Salmon River restoration projects, interested citizen scientists can participate in NYS Department of Environmental Conservation's **Wave Assessments by Volunteer Evaluators (WAVE)** project. DEC is recruiting participants for the 2018 summer sampling season to help with water quality assessments in streams and rivers. WAVE data collected by volunteers will provide valuable information to help identify healthy stream sites and flag sites with potential water quality concerns. This information is included in federal and state water quality reports and helps determine where restoration or conservation efforts are most needed.

All training materials are online so now anyone who can kick over a rock and has access to an online computer can participate. Participants visit stream sites once per year, anytime between July 1 and Sept. 30. Volunteers collect insects and other small organisms from the rocks and rubble on the stream bottom. If six or more of the "Most Wanted" organisms are found, the stream segment is assessed as having no known impacts and fully supporting aquatic life. If mostly "Least Wanted" organisms are found, the stream segment is flagged for further study, and DEC water quality scientists conduct more in depth sampling to identify and manage sources of impacts.

NYSDOT Announces TAP Funding

The New York State Department of Transportation (NYSDOT) is making funding available to support bicycle, pedestrian, multiuse path and non-motorized transportation-related projects as well as programs and projects that reduce congestion and improve air quality. Administered by the NYSDOT, these funds are made available to the State through the Transportation Alternatives Program (TAP) and the Congestion Mitigation and Air Quality Improvement Program (CMAQ). Combined, NYSDOT's TAP-CMAQ program provides reimbursement of up to 80 percent of project-related costs with the remaining 20 percent provided by project sponsors. Applications are due August 16, 2018

2018 TAP-CMAQ applications are completed and submitted through the NYS Grants Gateway at https://grantsreform.ny.gov/ (Opportunity: DOT01-TCMAQ-2018), a web-based portal for State agencies to post upcoming and available funding opportunities. Eligible entities/sponsors planning to submit a project application for TAP-CMAQ funding must register to obtain a Grants Gateway Login and ID at: https://grantsreform.ny.gov/Grantees.
