South Main Street Trailhead to Add Boat Launch and Other Amenities

According to Ron Blineby, Chair of the West Carthage Planning Board and S. Main Street Trailhead Project Committee, POWIS Construction Firm has been selected to install and construct a handicapped accessible concrete boat launch, dock and retaining wall at the South Main Street Trailhead. Scheduled to begin construction on June 15th, village work crews are coordinating efforts with Jefferson County Highway Department, Town of Champion and volunteers/donors to install and construct an open air pavilion/gazebo, lighting, pedestrian trail/walkway/access road, vehicular parking, tree plantings, park benches/bar-b-g's and other park amenities.

Funded through the Department of Transportation in 2009 through the Recreation Trails Program and administered through OPRHP, a fund raising committee was formed in 2013 to bridge the gap in funding to complete the project as designed. The project is the first phase of a multi-phased effort to create a more walkable community while enhancing the quality of life of residents.

Assisted and supported by GYMO Engineering Firm, NYS Tug Hill Commission, DEC/ACOE and OPRHP, the project advances recommendations outlined in the Destination Blueway: a Waterfront Plan for the Villages of Carthage and West Carthage. When completed, the project will provide linkages to existing motorized and non-motorized trails while interconnecting the waterfront and downtown areas.

North Shore, Salmon Rivers Councils of Governments Meet

The North Shore Council of Governments and the Salmon Rivers Council of Governments each met recently. Each approved a final version of their Intermunicipal Agreement, which has been streamlined and updated. The Intermunicipal Agreement will now be distributed to member municipalities for their consideration.

Both Councils of Governments also discussed priorities for potential grant applications from the Regional Economic Development Council Consolidated Funding Applications. In the North Shore area, the village of Cleveland is also pursuing a grant from the Northern Border Regional Commission with the assistance of the Commission. An extensive discussion on community needs and opportunities followed.

The towns and villages present also reported on the status of local projects and community development issues, including broadband, infrastructure improvement needs, and local businesses.

The two councils of governments have tentatively scheduled their next meetings for sometime in August, before the towns start the annual town budget cycle in September.

Mohawk Regional Economic Development Council Launches "MV500 Project"

The Mohawk Valley Regional Economic Development Council has launched the "MV500 Project," a comprehensive, co-ordinated strategy to create the regions bid to win a share of Governor Andrew Cuomo's \$1.5 billion in upstate revitalization funds. \$500 million will be awarded to each of the three upstate regions that create the winning plans. The MV500 committee will be accepting project proposals through the summer, with priority given to those that exhibit region wide impact, focusing on strengthening infrastructure and revitalizing communities. Residents in each of the six counties; Oneida, Herkimer, Fulton, Herkimer, Montgomery, Otsego and Schoharie; have the opportunity to participate in the process with the development of a Regional Community Survey, to aid the committee in outlining the regions strengths and challenges. The survey is available online at mv500.com/survey.

Town of Champion Sewer District #2 Improvements

At the June 1st meeting, members of the Town of Champion Board authorized Terry Buckley, Supervisor, to sign a "Northern Border Regional Commission Grant" application to construct improvements in Sewer District # 2. According to Bernier Carr & Associates (BC&A) representative, Caskinette Ford and Auto Supply is currently limited by the private septic system. Confronted with the decision to relocate or reduce employment of its 70 employees, the expanded sewer district will provide opportunities to sustain and expand business operations at the existing facility.

Scheduled improvements to construct new pipelines in Sewer District #2 by Lawman Heating and Cooling at a cost not to exceed \$1,323,599.21 and contract with Watson Electrical to complete electrical work at a cost not to exceed \$35,000 were also approved by members of the board. The new pipelines and upgrades to the existing district will also provide new access to the public sewer system by home owners located along the Cole Road.

Community Microgrid Being Explored

The Town of Wilna and Village of Carthage are supporting efforts to fund a Feasibility Study to explore options/ opportunities to establish a "Community MicroGrid" through the NYS Energy Research & Development Authority. A cooperative effort through the Carthage Industrial Development Corporation (CIDC) and the Jefferson County Industrial Development Agency recommendations outlined in the study will guide the next steps in setting up a microgrid.

The CIDC owns a 5 megawatt hydroelectric facility, located close to a 79 megawatt gas fired power generation facility. During an emergency situation associated with an electrical power outage, the microgrid would provide essential services with the needed power to support the community hospital, first responders and water treatment facilities until power could be restored to the area.
