
This training provides an opportunity for local planning and zoning board members to receive training on a variety of land use topics and to receive 2 hours of training credits.

# Comments Accepted on Draft Salmon River Fisheries Management Plan until April 23

The New York State Department of Environmental Conservation has released a draft Salmon River Fisheries Management Plan to guide the agency's continuing efforts to sustain and improve the Salmon River, one of New York's premier sportfish-

ing destinations. DEC's goal is to manage the Salmon River and its tributaries as a year-round sport fishery that provides anglers with the opportunity to catch an array of trophy-sized salmonids. DEC proposes a variety of strategies to achieve this goal, including improvements to its Salmon River Fish Hatchery, improved and increased angler access, efforts to promote ethical angling, protection and enhancement of critical fish habitats, and utilizing science and adaptive management to measure and achieve success.

The plan covers the period from 2018 to 2033 and focuses on lake-run trout and salmon in the 17-mile Salmon River corridor and the river's major tributaries

## **FY 2017 SAFER Grants Open**

The Department of Homeland Security (DHS), Federal Emergency Management Agency (FEMA) and Grants Program Directorate have issued a notice of the FY 2017 Staffing for Adequate Fire and Emergency Response (SAFER) grants, which will begin accepting applications on March 26, 2018. The SAFER program is composed of two activities: 1) hiring of firefighters by career, combination or volunteer fire departments and 2) recruitment/retention of volunteer firefighters by combination or volunteer fire departments.

Funding may be applied for ONLY by volunteer and combination fire departments in either category; by career fire departments in the "hiring of firefighter candidates" only and by municipalities and districts on behalf of fire departments which lack the legal standing to do so.

There is no requirement of matching funds for the SAFER Recruitment and Retention of Volunteer Firefighters Activity grants, however the SAFER Hiring of Firefighter Activity grants are required to contribute non-federal funds subject to a "position cost limit and a cost share" program. In order to apply for this funding opportunity you must have a Data Universal Numbering System (DUNS) number and be registered in the System for Award Management (SAM). Be aware that it can take up to 4 weeks after submitting your SAM registration for it to become active and then recognized by the Grants.gov system.

There is \$345,000,000 in funding available and there is no maximum grant award. # Northern Border Regional Commission Grant Deadline May 11

The Northern Border Regional Commission's (<a href="http://www.nbrc.gov/">http://www.nbrc.gov/</a>) 2018 grant round has been announced, with a deadline of May 11, 2018. For infrastructure grants, the maximum award is \$500,000; for all other categories, the maximum amount is \$250,000. A Letter of Notification is due <a href="March 30">March 30</a>, 2018, and is required to be sent to the state so they are aware of potential applications.

Eligible counties in NY are: Cayuga, Clinton, Essex, Franklin, Fulton, Hamilton, Herkimer, Jefferson, Lewis, Madison, Oneida, Oswego, Seneca, and St. Lawrence. All counties in NY are classified as "distressed," which makes them eligible for 80% funding and require a 20% match.

Eligible applicants are: State governments of Maine, New Hampshire, Vermont, and New York; Local governments (village, town, city and county); Other political subdivisions of States (regional planning commissions, authorities of the state); Indian Tribes; Non-profit entities.

Infrastructure is defined for NBRC purposes as publicly owned and publicly accessible fixed/physical 'hard' installations necessary for the movement of utilities, services, goods and people necessary to conduct business. Subcategories are:

- 1. Transportation
- 2. Basic Public
- 3. Telecommunications

Other grant categories are: Business and Workforce Development; Renewable and Alternative Energy; Basic Health Care Resource Conservation, Tourism, and Recreation
