## NYS Farmland Protection Grant Applications Available; Due June 13

New York State has announced the availability of \$26 million for farmland protection projects. The funding opportunity helps enable local initiatives intended to maintain the economic viability of the state's agricultural industry and its supporting land base and to protect the environmental and landscape preservation values associated with agriculture. ### Eligible applicants include:

- counties with state-approved agricultural and farmland protection plans;
- municipalities that have adopted a local farmland protection plan;
- soil and water conservation districts; and
- not-for-profit conservation organizations referred to as "land trusts"

## NYS Department of State Consultation Center at Local Government Conference

## Oneida Watershed Risk Map Discovery Project

The Federal Emergency Management Agency (FEMA), in partnership with the New York State Department of Environ-

mental Conservation (NYSDEC), has started a new Risk Mapping, Assessment, and Planning (Risk MAP) "Discovery" project for the Oneida watershed. FEMA's Risk MAP program is designed to provide quality flood maps and data and other tools and support to help communities take action to reduce flood risk and the potential loss of life and property.

During this Discovery project, FEMA and NYSDEC will ask for input from communities in the Oneida watershed on local flooding issues and mitigation activities, flood mapping needs, recent development, and other concerns related to flood risk. The results will be used to determine if a Risk MAP project to create revised flood maps or other products based on needs identified during the process is necessary.

Community involvement is very important because it will ensure that FE-MA and NYSDEC are aware of local flooding problems, flood mapping needs, and other related issues that communities in the watershed may be facing. This is your opportunity to discuss the local flood risks and the challenges your community faces when it comes to managing that risk directly with FEMA and NYSDEC.



You are invited to attend a Pre-Discovery webinar during which FEMA and NYSDEC will provide an overview of the Risk MAP program and the Discovery project.



## Osceola Tug Hill Cross Country Ski Center to Host Weather Station

Construction will take place this spring at the Osceola Tug Hill XC Ski Center (<a href="www.uxcski.com/">www.uxcski.com/</a>) to build a weather station as part of NYS's Mesonet Program (<a href="www.nysmesonet.org/">www.nysmesonet.org/</a>). The station will be located near the main building and will not interfere with the ski trails or disc golf course. Additional sites are planned around the region.

## SLELO PRISM To Work Along Fish Creek

The St. Lawrence Eastern Lake Ontario Partnership for Invasive Species Management (SLELO PRISM) plans to do an assessment in 2016 in Fish Creek. Fish Creek originates at Kasoag Lake in Oswego County, near the town of Williamstown. The creek meanders southeasterly for approximately 47 miles terminating into Oneida Lake. Both Kasoag Lake and Fish Creek are public fishing areas and although neither waterbodies are on the PRISM's Priority Conservation Area list, Oneida Lake is, and preventing the spread of invasive species into Oneida Lake is a priority for SLELO PRISM.

Fanwort, an invasive aquatic macrophyte, was recently discovered in Kasoaq Lake. The Kasoag Lake Conservation Association has taken the initiative to conduct control measures beginning in 2016. There is however concern that fanwort may have found its way into the outlet of Kasoag Lake (Fish Creek), and there-

fore poses a threat to downstream areas including Oneida Lake. In autumn of 2015 the SLELO PRISM was approached to assist with conducting a Fish Creek from Kasoag Lake to Oneida rather intensive assessment of Fish Creek to determine the downstream extent of the

fanwort population, if any, and to determine its proximity to Oneida Lake. With PRISM resources already being stretched and given the 47 mile assessment area, PRISM partners have come together to form an ad-hoc work group in support of this assessment.

This summer the SLELO Early Detection Team will begin an assessment of several highly probable areas along the length of Fish Creek in search of remote fanwort populations within the creek.

This effort may be supplemented with volunteers who would expand the search in high risk areas along the creek.

## **Northern Border Regional Commission Unveils** New Website and Grant Round

The federal Northern Border Regional Commission (NBRC) has unveiled a new website, www.nbrc.gov, and announced the availability of a new round of grants, due June 17, 2016. The NBRC will fund economic and infrastructure developments that:

- Develop the transportation, telecommunication and basic public infrastructure within the region;
- Assist the region in obtaining job skills and employment related education, as well as entrepreneurship, technology and business development;
- Provide basic health care and other public services for those areas that are severely economically distressed and underdeveloped;
- Encourage resource conservation, tourism, recreation, and preservation of open spaces in a manner consistent with economic development goals; and/or,
- Support the development of renewable and alternative energy sources.

Eligible counties in New York are Cayuga, Clinton, Essex, Franklin, Fulton, Hamilton, Herkimer, Jefferson, Lewis, Madison, Oneida, Oswego, Seneca, and St. Lawrence counties. All four Tug Hill counties are considered distressed and are eligible to request up to 80% of project cost. Eligible grant recipients include municipalities, counties, non profits, Native American tribes, and state agencies. The maximum grant award is \$250,000, and there is approximately \$1.7 million available for projects in NY. Successful grant applicants will be notified in August 2016. ## Floodplain Management Trainings Offered by NYSDEC

NYS DEC is hosting a series of floodplain management trainings across the state in the upcoming months, with two scheduled in Cooperstown, NY on Tuesday, May 10<sup>th</sup>, and in Norwich, NY on Wednesday, May 11<sup>th</sup>. The free, full-day training session will provide a detailed overview of FEMA's National Flood Insurance Program (NFIP), and review the community's roles and responsibilities in administering this program at the local level. The training has been approved for 6 hours of code enforcement, professional engineering, and certified floodplain management continuing education credits, and is targeted at code enforcement officers, floodplain administrators, building inspectors, planners, and engineers.
