## **DEC Accepting Applications For 10<sup>th</sup> Anniversary Environmental Excellence Awards**

The New York State Department of Environmental Conservation (DEC) is now accepting applications for the 2013 Environmental Excellence Awards program, Commissioner Joe Martens announced. This year celebrates the 10<sup>th</sup> anniversary of the Environmental Excellence Awards program which recognizes and gives visibility to outstanding, innovative and sustainable projects or programs.

"This year marks a milestone in environmental innovations for the Empire State," DEC Commissioner Joe Martens said. "As we recognize 10 years of the exceptional work accomplished by previous award winners, Governor Cuomo and I invite the best and the brightest to submit applications about their project's substantial environmental benefits."

DEC is especially interested in acknowledging projects that achieve significant environmental benefits through: green infrastructure projects; initiatives to reduce greenhouse gas emissions; cutting-edge pollution prevention technologies; initiatives to "green" businesses, farms, schools, recreational, health care and hospitality facilities; innovative wind, solar and biomass projects; creative natural resource/habitat protection or restoration efforts; energy efficiency improvements; innovative education and training programs; waste reduction and recycling efforts; manufacturing process improvements and creative approaches to urban forestry or farming, programs advancing "grown locally."

Eligible applicants include businesses (i.e., small, medium and large businesses, manufacturing, power generation, retail, agri-business, hospitality etc.); not-for-profit organizations; education, health care and recreational facilities; individual(s) and local, state, federal or Indian Nation government agencies implementing innovative, sustainable actions or working in creative partnership to improve and protect New York's environmental resources and contribute to a viable economy.

Completed applications for the 2013 awards must be post marked no later than Friday, May 10, 2013. Award winners will be honored at a 10<sup>th</sup> anniversary celebration and awards ceremony that will be held in the fall/winter 2013. Winners will have an opportunity to present and display information about their award-winning project or program.

Over the past decade, previous award winners have helped improve New York's environment through initiatives that have reduced more than 20,000 tons of CO2 and other greenhouse gas emissions; eliminated more than two million pounds of hazardous waste; saved at least 35 million kilowatt hours of electricity; reduced water consumption by more than 30 million gallons; diverted 7,100 tons of waste from landfills and preserved more than 150,000 acres of open space. #### SEQRA - DRAFT Full EAF Workbook Available For Public Review

The DRAFT Workbook for the Full Environmental Assessment Form (EAF) has been prepared and is available for public review and comment at <a href="https://www.nysfeaf.net">www.nysfeaf.net</a>. A printable PDF version of this DRAFT Workbook is also available on that site.

The DRAFT Full EAF workbook contains information to guide project sponsors and agency reviewers in the preparation and review of a Full Environmental Assessment Form (EAF). It contains background information on topics and will provide built-in links to spatial data needed to answer many of the questions asked in the Full EAF. The workbook should make it easier and more likely that project sponsors will have access to information that will allow them to provide an accurately completed Part 1. It will also make it easier for the reviewing agencies to confirm responses and provides guidance on how to determine the size and potential significance of an impact when completing Parts 2 and 3 of the Full EAF.

The revised model EAFs, which now do not take effect until October 7, 2013, are located on the DEC web site at http://www.dec.ny.gov/permits/70293.html.
