#### NY Broadband Round III Awards Announced

Governor Cuomo recently announced Round III awards for projects that will provide high speed broadband to homes, businesses and institutions in unserved or underserved areas across the state. The awarded projects support extension or improvement of broadband to residential, businesses and community anchor institutions, such as healthcare facilities and institutions of higher education. Providers serving the following Tug Hill towns were awarded in excess of \$5.4 million:

# Winona Forest Recreation Association Secures Parks and Trails NY Grant

The Winona Forest Recreation Association (WFRA) will receive \$19,000 from Parks and Trails NY to rehabilitate multi-use trails in the Winona State Forest, located in the towns of Boylston and Lorraine, Oswego and Jefferson Counties. WFRA is a non-profit organization that works collaboratively with the NYS Department of Environmental Conservation to provide a large, well-maintained network of trails for year round public use.

The grant award will be used to fund elements of a 17-mile trail rehabilitation project, designed to increase public access and significantly enhanced users' experience within the forest. The overall projects includes kiosks at parking areas, bridge construction, trail head posts and signs, and a picnic area with pavilion and picnic tables.

## Harmful Algae Bloom Summit held in Central New York

Over 100 people gathered at the new SUNY College of Environmental Science and Forestry's new gateway building to hear from experts from the New York State Department of Environmental Conservation (DEC), New York State Department of Health, New York State Department of Agriculture, and world renowned researchers to learn about the causes of and solutions to increasing harmful algae blooms

Harmful algae blooms caused beach closures on Oneida Lake in 2017.

Harmful algae blooms (HABs) are a natural phenomenon where naturally occurring algae, under the right conditions, will produce toxins and bloom excessively. These blooms threaten valuable recreation and drinking water resources, human health, and the food web dynamics.

Experts urge New Yorkers to know what to look for in the water, which is dense algae mats with a blue green color on surface waters that resemble pea soup, to avoid any skin contact with the bloom as it could cause nausea, vomiting, or skin rash, and to report the bloom to NYSDEC or local health departments. Experts also advise that partnerships and diligence are essential in developing and implementing actions that will reduce nutrient loading that causes these blooms.

Each lake is different, and land use is a primary driver of nutrient loading. Identifying where stormwater management, wastewater treatment, and residential and agricultural best management practices are needed, and working with local citizens and organizations to implement these actions, and monitor their effectiveness will be necessary to protect, mitigate, and prevent these future blooms under changing climate conditions.

At the summit's conclusion, the panelists were asked for recommendations that they'd like to have included in the action plans currently being developed. Suggestions included increased monitoring, plans that span the watershed as well as the lake, recognition that HABs affect everyone and everyone has a role in their reduction, and to work together and sustain our important freshwater resources.

Four summits have been planned. The SUNY ESF summit was the second to be held, following the Hudson Valley summit in New Paltz; two more summits are planned for the North Country in Ticonderoga, NY on Tuesday, March 20, and for Western New York in Rochester on Monday, March 26.

### **Great Lakes Basin Project Funding Available**

NY Sea Grant and NYS Department of Environmental Conservation recently announced \$200,000 available for Great Lakes ecosystem-based management projects through the NY Great Lakes Basin Small Grants Program. Up to \$25,000 is available for each project.

Proposed projects must use a complete ecosystem-based approach rather than a single issue or single species focus, incorporate stakeholder participation, and address key priorities in the New York Great Lakes Action Agenda. Those priorities include enhancing community resiliency and ecosystem integrity through restoration, protection, and improved resource management; and enhancing recreation and tourism opportunities that capitalize on the rivers and lakes, scenic beauty, and natural and cultural resources.

Eligible projects may include planning, design, implementation, information management tool development, demonstration projects, and targeted educational outreach. Not-for-profit organizations, county and local government or public agencies, municipalities, regional planning and environmental commissions, and educational institutions are eligible to apply.
