## DEC Holding Public Meeting Regarding Public ATV Connector Trail


In January 2013, the NYS Department of Environmental Conservation (DEC) received a formal request for an ATV connector link crossing a State Forests for an ATV trail. As part of the evaluation process, the DEC is seeking public comments to the requested connector trail proposal. The meeting will be held at 7:00 p.m. at DEC's Salmon River Fish Hatchery, 2133 County Route 22, Altmar NY 13302.

The Oswego County ATV Club Inc. has requested to utilize segments of an existing snowmobile trail and abandoned road located on the southern portion of Chateaugay State Forest as part of their club trail system. This trail would provide a connection from Stone Quarry Drive to Dam Road--both roads are open to ATV use by the Town of Orwell. The requested trail sections are located on and near the southern boundary of Chateaugay State Forest in the Town of Orwell, Oswego County. The total length of the requested portion of trail on state land is approximately one mile. Seven-tenths of this is found on the old abandoned Stone Quarry Road and the remaining three- tenths go on and off of state land following the existing snowmobile trail.

# Turin Celebrating Grand Opening of Boat Launch at Burdick's Crossing

The Town of Turin has planned a ribbon cutting at Burdick's Crossing to commemorate the completion of the newly enhanced boat launch and picnic area on Thursday, May  $30^{th}$  at 1:00 p.m. The public is invited.

Last year, Turin was awarded \$9,910 from the Iroquois Pipeline Community fund to improve access to the Black River at the Burdick's Crossing, a DEC fishing access site. The Town has a concurrent use agreement with DEC to maintain the property for public use. However, the earthen launch had become filled in with debris and become a carry-in-only site that was difficult to safely access. Improvements include the relocation of the launch 150' upriver for better drainage of seasonal flooding and to help stabilize the bank. The new concrete slab launch accommodates small motorized boats as well as kayaks and canoes. The gravel parking area was also expanded.

#### **DEC Begins Two More Unit Management Plans on Tug Hill**

Over the past two weeks the NYS Department of Environmental Conservation has announced that they are beginning Unit Management Plans (UMP) for two new units: Vienna Woods and Eastern Lake Ontario. The goal of UMPs is to outline the future management of areas in regards to recreation, timber management, maintenance of roads and boundary lines and the protection and enhancement of the natural and cultural resources found on the state properties.

The Vienna Woods unit is located in the Oneida County towns of Annsville, Camden, and Vienna. The two state forests included are Stone Barn and Fish Creek, which total 1299 acres. Also included in the UMP are 11 parcels of Detached Forest Preserve, totaling 888 acres.

The Eastern Lake Ontario unit is located in the Oswego County towns of Albion, Boylston, Orwell, Richland and Sandy Creek. The Unit is comprised of Altmar, Chateaugay, Sandy Creek Hill, and Trout Brook State Forests, about 5600 acres. It also includes conservation easement lands along the Salmon River (about 244 acres) and a pending acquisition (about 430 acres, including a large portion of the Conservation Easement lands) from National Grid Power Company which will join the Chateaugay State Forest and the Salmon River Falls Unique Area. For the Eastern Lake Ontario unit, there will be three open house sessions on June 5, 2013 at the Salmon River Fish Hatchery, 2133 County Route 22, Altmar NY, through the course of the day to gather public input to help draft the Eastern Lake Ontario Unit Management Plan. These open house sessions will be from 10:00 AM to noon, 2:00 PM to 4:00 PM and 6:30 PM to 8:30 PM. The open house sessions will allow the public to interact with DEC staff and view displays in an informal setting. Public comments will be accepted through July 8, 2013 and can be sent to:

Municipalities interested in pursuing NYS Department of Transportation TEP funding should be aware of two workshop requirements. In addition to the TEP workshop highlighted in the last Tug Hill Times, all potential applicants are also required to attend a Federal Aid 101 workshop. The only remaining scheduled Federal Aid 101 workshop in the area is in Syracuse on Wednesday, June 5, 2013, from 9:30am-4:15pm at the Rosamond Gifford Zoo, One Conservation Place, Syracuse, NY 13204. This workshop is actually a combined Federal Aid 101/TEP workshop.

#### **Trout Power Weekend**

Trout Power began as an idea to generate awareness about the West Canada Creek to ensure its long-term vitality for fishing and outdoor enthusiasts. Launched around education and awareness for the West Canada Creek in the Mohawk Valley in Upstate NY, Trout Power is a year-round initiative which is celebrated each year the first full weekend of June. Trout Power attracts over 2,000 people from across the country on Trout Power weekend.

Trout Power Weekend begins on June 7<sup>th</sup> and runs through the 9<sup>th</sup>. The weekend is filled with activities like fishing, a 5k run and a 28 mile garage sale in order to promote the well being of the creek. The weekend also helps local businesses prosper from this event. The weekend includes education and science based activities. Teams will be traveling across country to fish in a tournament and do a creel study. The study includes a data collection process where the challenge is to catch the smallest fish since there is no documentation that these wild fish are reproducing.

Towns from Oneida County to Herkimer County can prosper from people enjoying this 28 mile creek. Kayaking, bird watching and hiking are just a few other things to do besides fish around this body of water. Trout Power movement is not just a weekend event, but awareness throughout the year. #### More on the New NYS Grants Gateway

NYS's new Grants Gateway went "live" on May 15 at https://grantsgateway.ny.gov. In addition to requirements for municipalities discussed in the last Tug Hill Times article, the new system will also apply to nonprofits who apply for and receive grants from any NYS agency. Non-profits are being asked to pregualify with NY before they compete for State contracts, enabling them to make adjustments and answer concerns prior to entering a competitive bid process. Once they are registered with the Gateway, not-for -profits can fill out an online Pregualification Questionnaire. The questionnaire requests an upload of basic organizational documents and asks straightforward questions about a not-for-profit's capacity and integrity. Not-for-profits can secure their application materials in the Document Vault where they will be accessible to all State agencies, thereby reducing redundancy and conserving resources. Most importantly, not-for-profits will only have to prequalify once every three years, with responsibility to keep their information current throughout the three year period.
