Tug Hill Commission Releases

"The Roads Less Traveled: Minimum Maintenance Roads" Issue Paper

The commission has provided technical assistance to towns on minimum maintenance road designation for over two decades. To provide support to the region's councils of governments, the commission recently compiled an issue paper on the topic, available on the commission's website at www.tughill.org.

Town roads make up the majority of the transportation network in many rural areas of New York State. Towns are challenged to balance road maintenance that meets access requirements for residents and landowners, with keeping costs low, and therefore property taxes low, for those same residents and landowners. Minimum maintenance road designations, based on recommendations of the NYS Local Roads Research and Coordination Council, are an important tool used to strike that balance. Laws designating minimum maintenance roads have been adopted using home rule provisions. Recent legal challenges have prioritized the need for such designations to be authorized in state Highway law.


There are approximately 158 miles of minimum maintenance roads on Tug Hill, 100

miles of which serve as snowmobile trails in the winter. Total mileage of snowmobile trails on Tug Hill is approximately 925 miles. In a worst-case scenario, if towns lost the ability to designate minimum maintenance roads and had to convert all those roads to year-round vehicle accessibility, 15% of the snowmobile trails on Tug Hill would be closed.

Many of Tug Hill's minimum maintenance roads are a legacy of Tug Hill's original settlements in the early 1800's, with were more highly and densely populated than they are now. Roads were built to standards never meant to accommodate passenger vehicles year-round. By allowing the minimum maintenance designation, towns can maintain access for recreation, agriculture and forestry, at the same time following NY's Smart Growth principles.

2017 CFA Opens, Workshops Scheduled

A seventh round of the Consolidated Funding Application (CFA) has been announced for 2017. The CFA, a single application for multiple sources of state funding, is soliciting applications for funding to advance priorities of the Regional Economic Development Councils (REDC).

This year, there are over 30 programs available through 12 state agencies, including Empire State Development; NYS Canal Corporation; NYS Energy Research and Development Authority; Environmental Facilities Corporation; Homes and Community Renewal; Department of Labor; New York Power Authority; Office of Parks, Recreation and Historic Preservation; Department of State; Department of Environmental Conservation, Department of Agriculture & Markets, and Council on the Arts.

Training workshops will provide an overview of the Consolidated Funding Application (CFA) process, plus informational breakout sessions on specific areas of funding available for economic development projects. Workshops are open to local economic development officials, municipalities, non-profits, businesses and members of the public. Training available closest to Tug Hill are below:

This workshop will be worth two hours of training credit toward the annual training requirement for planning boards and zoning boards of appeals. All are welcome to attend this workshop, including municipal board members, municipal attorneys, and code enforcement officers.

CTHC Spring Meeting Well Attended

On Thursday April 27th the Cooperative Tug Hill Council (CTHC) held their annual spring meeting at the Alpine Restaurant in Constableville. Fourteen of the 18 CTHC municipalities were present, along with several Tug Hill commissioners and staff, as well as other guests. A total of 45 people enjoyed the excellent meal and meeting.

Following approval of the previous meeting's minutes and the current financial report, the election of officers for the year was conducted. The election results have Roger Tibbetts returning as Chairman; Doug Dietrich as Vice Chairman; Carla Bauer as Secretary and Ian Klingbail, Steve Bernat, Rosalie White and Paulette Skinner returning as Directors.



Chairman Roger Tibbetts announced that two of the four villages in the council's area, Port Leyden and Lyons Falls, have decided to join CTHC. The council's website update was discussed, work goals for 2017 were approved, and upcoming renewal of the council's inter-municipal agreement also was discussed.

Staff from the commission reviewed minimum maintenance road issues and presented a new issue paper recently prepared on the subject. Also discussed was an upcoming display at the NYS GIS Association's Map Day in Albany which will demonstrate the use of GIS analysis on the issue. The council also approved a new resolution in support of this vital legislation. Mickey Dietrich, GIS Specialist from the commission gave a presentation on various options for handling the presentation of the council's special areas maps. The meeting was closed with several supervisor topics discussed.

Wind Power Workshop Held

Over 60 local officials attended a workshop at JCC on Monday, April 24th that discussed the technical aspects and recommendations for zoning of utility scale (wind turbine farm) and private (residential/small commercial) wind energy conversion systems (WECS).

Also presented were changes in the wind power industry and drivers for development since the early 2000's.

John Collins, P.E. Project Manager, MRB Group in Rochester, NY, was the speaker. He is an expert in



structural and civil engineering, construction inspection, and project management and has a strong background in the electric utility and hydropower industries. He has specialized knowledge of energy-related regulatory requirements, including wind energy facility permitting, SEQR processes, and site plan review. AOT to Hold Regional Countywide Shared Service Seminars

The NYS Association of Towns (AOT) will be presenting a two-hour seminar on the new Countywide Shared Service mandate from the state on May 19 from 10:00 a.m.- Noon at the Embassy Suites by Hilton Syracuse, Dewitt. In addition to an examination of the legislation, there will be discussions of local issues and strategic considerations town officials may want to consider.

The first provides a brief overview of the elements in the Countywide Shared Services Property Tax Savings Plan, along with the Association of Towns' perspective on the state budget process.

The second discusses what town officials need to know about proposed shared services and transfers of function.

The third provides an overview of the data on shared services: what services are shared, obstacles faced and revenue earned.

Grants for Drinking Water and Wastewater Improvements

\$225 million is available through the Water Infrastructure Improvement Act of 2017 (WIIA) with one half allocated for drinking water projects and the other half allocated for wastewater infrastructure projects. There is also \$30 million available for the new Intermunicipal Grant Program (IMG), which will provide grants for water quality infrastructure projects to be undertaken by two or more cooperating municipalities.
