Town of Wilna Technology Improvement

The Town of Wilna board recently purchased a large 80" overhead screen monitor to provide more cost effective and efficient equipment in viewing GIS Map Viewer, site-plans, parcel overlay, annual budget & departmental reports and general information presented for discussion.

Using wireless high speed internet service, Code Officer and Assessor, Robert Ball presented a brief overview to members of the Planning & Municipal Boards and residents at the regular schedule meetings. According to Jon Storms, Planning Board Chair and member of the Jefferson County Planning Board, "the large screen provides board members with an opportunity to review site plans with greater detail and clarity that can get lost in smaller 8" X 11" paper copies. Pair that with the newly installed high speed wireless internet service and we can download GIS Map Viewer for easy access to online digital maps and overlay parcel information on to digital maps for a more comprehensive review."

Enthusiastically embracing the purchase of the new monitor, Supervisor Paul Smith commented "that the monitor can be a cost saving tool to reduce the number of paper copies that have to be disseminated to members of the board. Members of the different boards can view shared information in a shared setting." Additionally, the board stated the importance of digital information to local officials and suggested that being able to view online webinars and training sessions.

The **objective** of the FY 2014 AFG Program is to award grants directly to fire departments, nonaffiliated EMS organizations, and SFTAs for critically needed resources to protect the public, train emergency personnel, foster interoperability, and support community resilience. Fire departments and nonaffiliated EMS organizations may apply for each, any, or all of the five Operations and Safety component activities (i.e., Training, Equipment, Personal Protective Equipment (PPE), Wellness and Fitness, and Modification to Facilities), and Vehicle.

NYS Communities Can Now Apply for Arbor Day Community Grants

The NYS Urban Forestry Council announced funding is available for projects in small communities (population up to 65,000) to have an Arbor Day event and begin a community forestry program. This funding is provided by the USDA Forest Service and the New York State DEC Urban Forestry Program. Grant applications are due December 2, 2014.

Grants of up to \$1,000 will be awarded to communities or non-profits that work in partnership with municipalities to celebrate Arbor Day 2015 and form a shade tree committee within the municipality.

The intention of this grant is to help communities begin a community forestry program. Communities that are currently a Tree City U.S.A. are ineligible, as are communities that have any component of the Tree City U.S.A program such as a tree ordinance; a tree board and an inventory or a management plan. Foundations of Scanning Historical Photographs Webinar November 18, Tuesday 2:00-3:00 p.m.

Photographic materials in all their variety are among the most difficult records to manage and make accessible. With the dawn of new digital technologies, you are now able to share your historical photographs with a wider audience and save wear and tear on the originals. Digitizing your photographic collections opens the door to creative and interesting applications never before dreamed possible. Consider the blossoming world of blogging, websites, epublications, social media, and so forth as natural venues to share your visual historic treasures. But there are many issues to consider as one prepares for such an endeavor. This webinar will introduce the basic principles of scanning historical photographs.

Emergency Preparedness Training

An Emergency Preparedness training will be held November 20 at 6:00 p.m. at the Carthage Central High School auditorium, 36500 Route 26, Carthage.

The New York National Guard will host the training, along with experts from the Division of Homeland Security and Emergency Services' Office of Emergency Management, the Office of Fire Prevention and Control, and local emergency management personnel. During the two hour training, participants will learn how to prepare for a potential disaster, including developing a family emergency plan and stocking up on emergency supplies. Participating families will each receive a free disaster preparedness kit for getting through the immediate aftermath of a disaster. The kit contains items such as a first-aid kit, face mask, a pocket radio with batteries, food bars and an emergency blanket. In addition, everyone who attends will receive a certificate of completion. The program will also have a skilled volunteer registry, where community members with specialized skills that are needed in an emergency can sign up. Preregistration is required.
