Tug Hill Commission Annual Dinner a Success

Over 90 people attended the Tug Hill Commission's 2016 annual dinner, held at the Tailwater Lodge & Barn in Altmar on November 10. Attendees were able to view the

new Venerable Folks of Tug Hill exhibit and portraits, a collaborative project with artist, Loretta Lepkowski, Tug Hill Tomorrow Land Trust, Tug Hill Commission and Traditional Arts of Upstate New York. The people selected as Venerable Tug Hill folk exemplify the traditions and spirit of the Tug Hill region. The exhibit will be traveling to various locations both in and outside of the region. Many attendees also took tours of the new Tailwater facility, which is a great example of adaptive reuse of an abandoned building, in this case a former elementary school.

The keynote speaker for the evening was Ken Lynch, Executive Deputy Commissioner of the NYS Department of Environmental Conservation and former Region 7 Director. Ken's presentation high-



lighted many of the ongoing efforts of the Department of Environmental Conservation in the Tug Hill region, including the ownership soon of 2,800 acres of National Grid land along the lower Salmon River and the Salmon River Reservoir; the new Tug Hill Traverse non-motorized trail being built in the core forest of Tug Hill; and the pending acquisition of over 3,000 acres of former Harden property in the towns of Orwell and Redfield.

Tug Hill Commission Meeting Scheduled

Tug Hill Invasive Species Protection Zone Field Work Complete

The Tug Hill Invasive Species Protection Zone (ISPZ) was first delineated in 2012 by the St. Lawrence Eastern Lake Ontario Partnership for Regional Invasive Species Management (SLELO PRISM). It is an area around the Tug Hill core forest dominated by native species with relatively little impacts from many invasive species. The SLELO Early Detection
Team conducts field surveillance on the ISPZ to monitor for
invasive species encroachment
every two years. In 2016 the
team found two sites where
invasive species (Japanese
Knotweed and Pale Swallowwort) were encroaching on the
ISPZ boundary. SLELO's rapid
response team then treated
each site with landowner permission. The map to the left
shows the ISPZ boundary and
the two locations of treatment.

Map shows: Early Detection surveillance of the Tug Hill ISPZ occurred August 9-15 2016. Two invasive species were observed in close proximity to the

ISPZ boundary. The SLELO PRISM Rapid Response Team, treated both sites with landowner permission.

Site 026 was near County Route 96, (swallow-wort).

Site 121 was near Florence Road, (knotweed).

NOCCOG Monitors Potential Changes in Sales Tax Distribution

A committee has begun the task of evaluating a potential change to the formula currently used to distribute sales tax to Oneida County municipalities, prompting anxiety among local officials; particularly the villages.

In addition to County Executive Anthony J. Picente the committee consists of Board of Legislators' Chairman Gerald J. Fiorini, Majority Leader George E. Joseph, Minority Leader Philip M. Sacco, Rome Mayor Jacqueline M. Izzo, Utica Mayor Robert M. Palmieri and three town supervisors selected by the president of the Oneida County Association of Towns.

The supervisors are Robert J. Meelan of Kirkland, Scott M. Musacchio of Verona and John Urtz of Lee.

The current formula distributes a portion of sales tax collected to towns and villages based on property values. For many towns and villages, sales tax accounts for well over half of annual revenues.

The committee is scheduled to meet again on November 21st in a session closed to the public.

Workshop on Article 10 Held at JCC on November 14th

Over 100 local officials and citizens attended a workshop at JCC on November 14 about the Article 10 review process for the siting of electrical generating facilities. Co-hosted by the Tug Hill Commission and Jefferson County Planning, NYS Department of Public Service's General Counsel Paul Agresta provided the audience with a very thorough and understandable overview of the Article 10 process, which became law in 2012. Mr. Agresta stressed that the review process was enacted so that stakeholders could be brought together to balance the needs of the consumers (of electricity) with the environmental compatibility of a project designed to produce electricity, such as large wind farms. There are several opportunities for interested parties to be involved in the process, including being a participant, a party, an intervenor or even being one of two Ad Hoc siting board members, which are nominated by the communities and elected by the NYS Senate and Assembly. There was lengthy discussion about local laws and how they are applied during the siting process. Under Article 10, local laws must be followed, unless they are deemed to be overly burdensome by the siting board. An example of an overly burdensome law might be a local law prohibiting towers over 100 feet tall, when, because of current technology, wind towers are now well over 200 feet tall. There is a handout on our website (within the *Article 10 Handout for Local Officials* link) titled *Resolution Adopting Local Law Regulations* that speaks to the topic of local laws and home rule in depth.
