Village of Herrings Votes for Dissolution

Based upon a 19-9 electorate vote in favor of dissolving the Village of Herrings by residents during the general election, held November 3rd, the village will apply for available funding through the Department of State to develop a dissolution study that will be used to guide the process. Funding will be used to contract for professional services to analyze the fiscal impacts of the dissolution, examine current operations and cost as well as outline alternative options/opportunities for review and consideration.

On July 31st, the Village of Herrings clerk received a petition from electors requesting to dissolve the village. According to Mayor Christal Loeffler, the clerk verified the format of the petition and that signatures were determined to be valid according to Article 17 of NYS General Municipal Law. On September 6th, the village board met to review the findings of the clerk and to schedule the dissolution referendum for November 3rd.

The village held a dissolution information session on November 1st to provide residents with an opportunity to hear from a representative of the Department of State, Robert Roeckle, about the process and respond to questions/concerns. Now that voters have approved the dissolution referendum, the mayor will appoint representatives from the village and town to serve on a committee to guide the development of the study.

According to state law, the village has 180 days to complete the study. Subject to a permissive referendum, a public hearing will be scheduled within 90 days after the completion of the study for public review. Based upon final comments, amendments can be made prior to the board's approval. If residents call for a referendum vote and the study is rejected, the process can then be stopped.

NOCCOG Annual Dinner Held

Local leaders gathered at the Lake Delta Inn in Rome on October 29th for the 32nd annual meeting of the Northern Oneida County Council of Governments. About 90 local officials representing nearly all 19 participating municipalities were in attendance to hear MV500 Co-Chair Alicia Dicks present the committees proposal recently presented in Albany in a bid for a portion of Governor Cuomo's \$1.5 billion in Upstate Revitalization funds. The gathering also included an overview of NOCCOG's activities over the past year as well as the election of officers, which includes Chairman John Doiron from Ava, Vice-Chairman Arnie Talgo from Steuben, Fiscal Officer Betsy Mack from Trenton, and Directors Bob Sauer from Camden and Mark Trnchik from Annsville.

Tim and the Village of West Carthage has been a part of the JIMI (Joint Infrastructure Management Initiative) project since it's beginning. He has helped out others in their use of GPS and GIS technologies for the benefit of their communities, even presenting at the local government conference in Watertown. He has strongly embraced GIS and has shown others that no matter what their background is in GIS, everyone can learn it if they put in the time and are dedicated to the effort.

Tim and the Village of West Carthage have utilized Cartegraph for their asset management, a high level accuracy GPS unit for collecting and relocating infrastructure, and he has even taught himself how to utilize a free open source GIS program called "QGIS", which provides editing, analysis, and map making capabilities.

Tim was recently in a video called "Emerging GIS Series: Emergency Response", which is focused on showing local governments throughout New York State how GIS can be used within their community. Workshop on Future Lake Ontario Weather Extremes

New York Sea Grant is inviting public stakeholders in the Lake Ontario region of New York State to share their best thinking on what actions are needed through lake and watershed planning to prepare for possible future extreme climate conditions and population changes in the region at workshops on November 10, 6:30 p.m. in Watertown and November 12, 6:30 p.m. in Rochester. Approximately 2/3 of the Tug Hill region falls within the Lake Ontario watershed, and lake effect precipitation plays a big role on Tug Hill's weather.

Specific areas for discussion at the workshops will include potential actions related to water resource management, infrastructure, land use and zoning, governance, economic development related to agriculture, recreation and tourism, and ecosystem management. The workshops will consider potential recommendations to address both exceedingly wet and dry futures in the Lake Ontario region through stormwater management, riparian buffers, wetlands restoration, stream hydrology, job training, and energy considerations.

New York Sea Grant will add public input to a report that will be presented to local, state and federal agencies and stakeholder organizations to assist future planning efforts.

Seating is limited for the November 10th workshop at Cornell Cooperative Extension Jefferson County, 203 North Hamilton Street, Watertown.

The November 12th workshop in Rochester will be held at the Rochester Museum and Science Center Bausch Auditorium, 657 East Avenue, Rochester. Doors open at 6:15pm for each workshop.

Tug Hill Commission Available GIS Resources

Do you know what GIS resources are available for your local government through the Tug Hill Commission? Did you know that the Commission's geographic information system (GIS) services are free to local governments within the Tug Hill Region? Here is a quick overview of what is available.

The Commission provides mapping services to many of our communities, most often in the form of paper maps. These are useful tools for local governments to help make informed decisions. And who doesn't like an interesting map on their wall? Yet, with the digital age now here, we find many local governments want to use GIS to help collect and update data within their community.

The Commission welcomes opportunities to help local governments build capacity within their own organizations to use GIS. That starts with providing education and training, based on the age-old adage "knowledge is power." Our goal is not to focus on one solution, since there usually is not one solution that fits everyone. We work to provide towns and villages with information on different solutions that are available and help them find the one that might work best for their local government.

For those who may not have the capacity to build a complete GIS application for their municipality, there are many alternatives available. We do offer some alternatives ourselves; here is a brief list of some of the services we can help provide.

1. Online Mapping

Towns and villages can display their data in our online map viewer, free of cost. There are other options for displaying data that may have a cost associated with them, and we have information on those as well.

2. Mobile GIS

We can work with you on a mobile solution, so you can update and collect data using a tablet or smartphone in the field. For GIS Cloud project based applications this can be a no cost solution; other options may have a cost associated with them.

3. Editing Capabilities

We are familiar with a variety of desktop GIS programs that can meet different needs. Most recently we have been working with an open source free desktop program called "QGIS". We can also provide editing capabilities to our GIS Cloud application.

Erosion & Sediment Control Training Offered in Watertown

The Jefferson County Soil & Water Conservation District is offering a NYS DEC endorsed 4-Hour Erosion & Sediment Control Training on Friday, November 20, 2015 from 8:30 am - 12:30 pm. The cost is \$75 per person, non-refundable, and a Blue-Book "Lite" is provided with each registration. It will be held at the Italian-American Civic Club, 192 Bellew Avenue, Watertown, NY.

Under the NYS DEC's Stormwater Permit GP-0-10-001, all developers, contractors and subcontractors must identify at least one trained contractor from their company that will be responsible for implementation of the SWPPP, and have at least one trained contractor on site on a daily basis when soil disturbance activities are being performed. Pre-payment is required. Photo ID registration begins at 8:00 am. Arrivals after 8:45 am will not be allowed to attend. Upon completion of the course, participants will receive a NYS DEC stormwater training number on a certificate and wallet card good for three (3) years.

Emergency Response GIS Video

The NYS GIS Association was awarded a \$10,000 grant by The Fund for The City of New York to assess the GIS needs and resources for municipalities throughout NYS and identify potential strategies and solutions for the increased use of GIS. Although GIS is used extensively in many areas, there are still places in New York State that do not use GIS or could use it more effectively.

Part of the funding was used to produce a video on emergency response and how GIS can be used to help local governments in these situations. This video is a resource for all local governments within New York State. In this video you will see two local governments and a fire department from within the Tug Hill region. They are the Copenhagen Fire Department, Town of Martinsburg, and the Village of West Carthage.

Town of Wilna Dog Control Services

On October 29th at a special meeting, members of the Town of Wilna Board approved a motion to end their contract with Jefferson County for dog control services and enter into a year-long contract with a trained dog control officer from Beaver Falls. A letter was sent to the county notifying them that when the current contract expires on December 31, 2015, the town will no longer require dog control services.

According to Paul Smith, town supervisor, the town pays Jefferson County \$23,715 annually for dog control based upon the number of dogs licensed within the whole township. However, the county dog control service does not extend into the 3-villages located within the town. "We get charged for dogs located within the villages but we're not receiving service in the villages." Following failed attempts to resolve the ongoing issue, the town decided to explore alternative options/opportunities to provide dog control services.

Having received approval from the Department of Civil Service, the town board is expected to formally approve the new position at the November 5th meeting and seek approval of the pre-qualified hire. Contingent upon approvals, the new position will take effect on January 1st 2016 at an annual cost of \$14,400 plus the cost of business cards, cell phone and cell phone service.

Land Use Planning Workshop

Presenter Robert Somers, PH.D., Manager of the Agricultural Protection Unit of the NYS Department of Ags & Markets will cover: the interaction between NYS Ag Districts Law and local zoning regulations; local regulation of farming operations; how farmers can request a review of potentially restrictive regulations.
