New Forestry Paper Explores Opportunities for Creative Investment

Over the last several decades, as farmland has converted to forests and pulp and paper mills have shut down, an abundance of biomass is growing and becoming available at a time when emerging markets in the forest industry will demand wood for the production of heat, energy and bio-products. The Regional Economic Development Councils are urged to consider these markets and their potential for economic development in a new paper published by the Tug Hill Commission: *Forests, Forestry and the Forest Products Industry: Opportunities for Creative Investment*, which is available on the Commission's website at http://www.tughill.org/wp-content/uploads/2011/09/forestry_paper_FINAL_October_2012.pdf. Recommendations include such topics as Brownfields and Retooling Old Forest Industrial Sites, Lean Manufacturing, Expanding Markets for Wood Products, Recreation and Tourism, Invasive Species and Greenhouse Gas Sequestration.

A Future With the Adirondack Railroad Meeting November 20th



A few weeks ago the Adirondack Railroad Preservation Society (ARPS) and Iowa Pacific Holdings, LLC (IPH) announced a new partnership to establish roles and responsibilities in the development of train service between Lake Placid and New York City. This development provides tremendous opportunities for communities and stakeholders along the entire Adirondack Rail corridor for growth in tourism, recreation and economic development.

The Tug Hill Commission and Northern Oneida County Council of Governments have organized a meeting with representatives of ARPS for a conversation on what this may present to Oneida County communities and other communities throughout the North County and Mohawk Valley. ARPS President Bill Branson will provide an overview of the agreement with IPH and what it means for the future of the rail corridor. There will also be representatives of the Adirondack North Country Association (ANCA), Oneida County and community leaders and stakeholders from communities in the NOCCOG region and beyond.

This meeting will be an opportunity for communities along the southern end of the Adirondack Railroad to learn more about the agreement and to provide input and ideas on how the future of the Adirondack Railroad will benefit the region's economy. NOCCOG held their annual meeting at the Delta Lake Inn in Rome on Thursday, October 25th. With over 100 people pre-registered, including representatives of all 19 NOCCOG towns, this was a excellent turnout. NOCCOG approved their annual budget for 2013 and re-elected their Executive Committee Officers with John Doiron as chairman, Arnie Talgo as vice chairman, Mark Scheidelman as fiscal officer, Bob Sauer and Mark Trnchik as directors. The NOCCOG proposed budget for 2013 was approved, with dues reaming the same for 2013 at \$1,000.

The evening's speaker was Ken Tompkins, Executive Director of the Mohawk Valley Regional Economic Development Council and Regional Empire State Development Corporation Director. Ken provided an overview of the MV REDC Strategic Plan and highlighted opportunities for rural Northern Oneida County communities and businesses as they look to spur economic growth. Ken was genuinely pleased with the turnout for the NOCCOG event and the opportunity to reach out to so many Oneida County leaders.

Emergency Preparedness and Your Records

The New York State Archives is available to help you protect your records from disasters. To be prepared for a disaster, keep in mind the following regarding your records and collections:

- Review your emergency response plan to ensure phone lists and other contact information are current.
- Revisit your municipality's priority collections (vital records) lists and locations.
- Verify your facilities layouts, with attention to evacuation routes and locations of stairs, exit doors, fire hoses, water and CO₂ fire extinguishers, emergency lights, alarm pull boxes, sprinkler shut-off valves, and first-aid kits.
- Identify and, if necessary, acquire alternative power sources such as generators
- Gather plastic sheeting to be used as covering for collections, filing cabinets, and computer equipment stored in vulnerable locations.

Vienna Moving Forward on Zoning Update

The Vienna Planning Board is wrapping up a major amendment to the town's zoning law. The new and improved law is intended to better implement Vienna's 2007 Master Plan. Among many changes, the new law establishes better guidelines for home based businesses, fences, recreational camping vehicles, flag lots, motorized vehicle parks, wind turbine towers (windmills), and signs. The law's next stop is the Oneida County Planning Board for 239-m review.

Request For Proposals Issued for 2013 Projects Addressing Invasive Species

As the host organization for St. Lawrence Eastern Lake Ontario Partnership for Regional Invasive Species Management (SLELO-PRISM), The Nature Conservancy is offering funding to complete projects during the 2013 calendar year. Non-profit organizations, local governments and institutions located or serving areas within the boundary of SLELO may apply. The four project categories for which SLELO-PRISM is seeking proposals are:

- Early detection and site assessments to evaluate invasive populations.
- Eradication and control of invasive species populations PRISM-wide or in managed areas to protect rare species and significant natural communities, recreation resources, and agriculture including restoration of control sites.
- Education and outreach for prevention.
- Projects that address whole systems (eco-regions) prevention and pathway issues and/or citizen science based research on controls, best management practices, etc.

Applications must be postmarked or delivered by 3:00 pm November 28th, 2012. At least \$90,000 in project funds will be available. Applicants may request up to \$25,000 with no match required, but it is encouraged. Your creativity is also encouraged!
