# **SEQR Training Scheduled in Ava**

The Commission will be conducting a two-hour State Environmental Quality Review Act (SEQR) training session at the Ava Town Hall located at 11468 State Route 26, Ava on November 5th at 7:00 pm. This session will cover what planning and zoning officials must know about the SEQR process during site plan, special use and subdivision reviews, and appeals to the zoning board of appeals. # Black River Initiative Advisory Committee Meets

A group of stakeholders gathered at the Champion Town Hall on October 9th to discuss projects occurring on and surrounding the Black River Trail corridor and within its watershed. Facilitated by the Tug Hill Commission, the Black River Initiative Advisory Committee (BRIAC) is a combined group of stakeholders distilled from three separate, but complementary projects: the Black River Blueway, Scenic Byway, and Watershed. Although funded separately, all three include interrelated pieces that promote the abundant natural, cultural, and recreational resources that the Black River provides. Individually, each project was guided by separate local advisory committees that helped administer grant funding. Now the combined group meets to exchange ideas and to brainstorm projects that promote all things "Black River."

Attendees represented Oneida County Convention and Visitors Bureau, NYS Department of Environmental Conservation (DEC), Development Authority of the North Country (DANC), City of Watertown, Village of Lyons Falls, Lewis County, NYS Department of Transportation (DOT), Thousand Islands Tourism Council, River Area Council of Governments (RACOG) and Lyons Falls Alive. They discussed many topics including City of Watertown's Sewall's Island re-development, trail planning, Black River navigation improvements, water quality project coordination, tourism business development; event coordination, and regional marketing efforts.

Especially interesting, was learning from our Raquette River Blueway Corridor special guests: Mary Jane Watson, Fred Hanss and Ruth McWilliams. A lively exchange of ideas took place among the participants about coordinating whitewater events, promoting North Country whitewater destinations and developing strong business plans for entrepreneurs. Members of the BRIAC plan to attend a Raquette River Blueway Corridor committee meeting in the future to continue the exchange of ideas.

# Parks & Trails New York's *Growing the Grassroots* Capacity Building Grants

Parks & Trails New York's *Growing the Grassroots* Capacity Building Grants are being offered to enhance the long-term sustainability of park and trail not-for-profit organizations by helping them better fulfill their missions; improve their reach, effectiveness, and impact; leverage resources, and increase community support for park and trail planning, development and/or stewardship. Applications must be submitted by **5:00 p.m., Thursday, October 30, 2014. All applications must be submitted online.** Applications cannot be mailed, emailed or faxed. Awards will be made to local or regional organizations that are classified by the IRS as 501(c)(3) or who operate under the fiscal sponsorship of a 501(c)(3) and whose primary mission is stewardship of a specific New York park or trail that is or will be open to the public.

Grants of up to \$4,000 will fund activities that help develop and strengthen the skills, processes and resources that not-for-profit organizations need to survive:

- Organizational start-up e.g., incorporation, initial staff, equipment purchase
- Professional consulting services that aid organizational development e.g., fundraising, communication, marketing, membership, strategic planning, financial management
- Board and staff training
- Volunteer recruitment, training and/or recognition program
- Communications graphic design, development or enhancement of a logo, website, newsletter, or other communication tool; printing and distribution of brochures, newsletters, or other educational or outreach materials. Brochures and maps can include information on the park or trail, but must also include organizational information and solicitation of membership
- Park or trail capital project that will raise the visibility and capacity of the applicant, e.g. kiosk or sign.

#### Awards will be based on:

- Ability to initiate, grow, strengthen, or transform the organization
- Organization's demonstrated financial need; preference will be given to organizations with annual budgets of less than \$100,000
- Detailed, documented, and realistic budget. See a <u>sample budget</u>.
- Clearly articulated project goals, tangible outcomes and well-defined, objective measures of success
- Applicant support for the project as demonstrated by financial and/or in-kind commitment
- Ability to leverage other opportunities, such as partnerships and funding sources
- Creativity and the ability of the project to serve as a model for other groups
- Visibility degree to which project will promote the organization and foster public use, appreciation, stewardship, and development of applicant's park and/or trail
- If applicable, plan for sustainability of the project after grant period ends

#### Preference will be given to:

- Projects that leverage the amount of funds requested with significant cash or in-kind contributions from project partners.
- Organizations who have not received a Growing the Grassroots grant within the last three years.
- Organizations with annual budgets of less than \$100,000.
