URGENT! Need Your Input Now!

State Senator Patty Ritchie has created a **Mandate Relief** Working Group, co-chaired by Clayton Town Supervisor Justin Taylor and St. Lawrence County Legislator Kevin Acres of Madrid. This group is tasked with identifying state regulations and mandates that are ineffective, overly burdensome and costly to local taxpayers.

The working group, made up of representatives from county, village and town governments as well as school districts, will offer recommendations on mandates that New York needs to abolish or change to help local governments reduce costs to taxpayers. They will be meeting in the next few months to discuss mandate relief.

Governor Cuomo's **Mandate Relief Redesign Team Report,** as well as reports and ideas from the NY's Conference of Mayors, Association of Towns and Association of Counties, contain many mandate relief initiatives local governments can support. More about the Mandate Relief Redesign Team and the report can be found on the website at www.governor.ny.gov/mandaterelief.

However, the Mandate Relief Redesign Team Report and other sources do not include suggestions such as:

- Support for Low Volume Roads legislation
- Amending the "New NY Government Reorganization and Citizen Empowerment Act" regarding elector initiated dissolutions/consolidations
- Amending state law to allow for consolidated justice courts
- Adding health care to the 2% tax cap exemption list
- Reinstating "oil and stone construction" back into CHIPS reimbursements
- Streamlining SEQR to integrate into zoning and planning processes

These are but a few ideas that have been worked on or discussed over the years. If Tug Hill communities want to be heard on this effort, we need your input soon. We are trying to develop a set of possible recommendations to convey to Senator Ritchie's working group by October 15 th so please let us know your ideas.

NYS Association of Towns to Host Tax Levy Cap Webinar Managing In a Tax Levy Capped World, Thursday, September 29, 11:00 AM to 2:30 PM

The NYS Association of Towns and the NYS Government Finance Officers' Association will host a webinar that will provide an overview of the new property tax levy cap from the Office of the State Comptroller and strategies for evaluating, prioritizing and managing government services more efficiently. The webinar will address:

- The latest updates on guidance from the OSC on issues pertaining to local government implementation of the real property tax levy cap;
- Strategies for restructuring local government service delivery systems;
- How to evaluate the degree to which a particular local government service is legally mandated; and
- How one local government (the City of Rochester) has implemented systems and programs to provide local government services in a more efficient and cost effective manner.

Attendees will also have the chance to submit questions to a panel of presenters during the program. This program will qualify for 1.5 CPE in the area of Government Specialized Knowledge. Salmon River Fish Hatchery Open House Saturday

The Salmon River Fish Hatchery will be open as part of National Hunting and Fishing Day this Saturday, September 24th, from 9:00 AM to 4:00 PM rain or shine, free admission. Salmon are in the middle of their migration and there will be many displays and activities for both adults and children, including NY Sea Grant with their "Discover Clean and Safe Boat" program, the Coast Guard Auxiliary, and Brookfield Power promoting the "Wear it Oswego" program. Visitors can tour the hatchery with DEC staff, learn about fishing for Pacific salmon, and learn about rare and endangered fish. Volunteers will teach how to the there is fish identification, discovery of creatures of Beaverdam.

MVREDC Holds Public Participation Meeting

The Mohawk Valley Regional Economic Development Council held its first of three community outreach workshops Monday, September 19, unveiling its draft for a five-year strategic economic development plan. The public was asked to comment on the Council's draft vision statement and the results of its SWOT exercise.

About 80 people attended the public meeting in the Science and Technology Building at Mohawk Valley Community College. The Council has less than two months to put its plan together, but members already have a good idea of what the final draft will include. "It's going to involve some form of technology, agriculture, tourism and health care, all of those things that the citizens of the Mohawk Valley are engaged in," says President of SUNY IT, Wolf Yeigh, the Council's cochairman.

The Council is one of ten regions competing for state grants and tax breaks. Each region must submit a five-year strategic economic development plan that would promise sustainable growth in the area. After the plans are submitted and reviewed, the four regions with the best plans will be awarded \$40 million each. The remaining 6 regions will split \$40 million. NYS Library Conservation Preservation Discretionary Grants

The New York State Program for the Conservation and Preservation of Library Research Materials provides \$500,000 each year for preserving materials in the collections of libraries, archives, historical societies and similar agencies. The grant awards for 2012-2013 will be limited to a minimum of \$2,500 and a maximum of \$40,000. The purposes of the Conservation/Preservation program are to encourage the proper care and accessibility of research materials, to promote the use of development of guidelines and technical standards for conservation/preservation work, and to support the growth of local and cooperative activities within the context of emerging national preservation programs. 
