### CTHC Fall Meeting Held, September 22<sup>nd</sup>

The Cooperative Tug Hill Council (CTHC) held their annual fall meeting at the Steak and Brew Restaurant in Turin on Thursday September 22nd. Fourteen of the sixteen CTHC towns were present, along with several members of the Tug Hill Commission and commission staff and several other guests. A total of 38 people enjoyed an excellent meal and the meeting which followed.

The evening's speakers, Marguerite Wells from Invenergy and Bill Moore from Hudson Energy Development, spoke about their local wind projects. Ms. Wells spoke about the wind industry in general and gave the council an overview of the Number 3 wind project which her company is undertaking. Mr. Moore spoke about the possible wind project in southern Jefferson County and the added issues in that area due to the need for an adequate transmission system to carry the power safely to the grid.



The meeting closed with supervisor topics, including thanks from attendees for the commission's work on the minimum maintenance roads issue and stressing the importance of the issue for many of the council's towns. In addition there was a discussion of a "ransonware" attack on one town's computers and the necessity of external back-up systems for data.

# **Great Lakes Action Agenda Sub Basin Work Group Meetings**

Towns and villages in the Tug Hill region are part of the Lake Ontario sub-basin, and New York State is a participant in the Great Lakes Action Agenda, who's purpose is to identify pressing problems and actions needed to protect natural resources, environmental quality and produce resilient communities. This helps focus federal and state programs on the most important challenges faced by this region of the Great Lakes.

The New York State Department of Environmental Conservation (DEC) is holding a series of meetings in October 2016 for interested parties to identify priority projects to advance the goals of the Great Lakes Action Agenda. The meeting for the South East Lake Ontario sub-basin, which includes most of the Tug Hill region, will be on Wednesday, October 26, from 10:30 a.m. to 2:00 p.m. at Sabin Hall at Fair Haven Beach State Park, 14985 State Park Road, Sterling, New York 13156.

There will also be a meeting for the North East Lake Ontario sub-basin on Tuesday, October 25, from 10:30 a.m. to 2:00 p.m. at Keewaydin State Park Marina pavilion, 45165 New York 12, Alexandria Bay, New York 13607.

#### Black River Trash Bash Update

The Lewis County Water Quality Coordinating Committee participated in the Black River Trash Bash on Monday September 19th at Otter Creek State Forest. Over 165 cigarette butts were collected, along with numerous food wrappers, beverage bottles and cans, clothing articles and plastic grocery bags. In all 35 pounds of garbage and 15 pounds of recyclables were removed from the banks of Otter Creek, which flows into the Black River.

The Jefferson County WQCC, Lyons Falls Alive, Haderondah 4H Club, Adirondack Citizens Advisory League and the American Society of Civil Engineers Student Club from Utica will all be reporting on their events soon, so stay tuned to the Tug Hill Times for more news from the Black River Watershed.



# Steering Committee and Technical Working Group of Fort Drum JLUS Meeting Held at JCC

Commission staff attended the first meeting of the Joint Steering Committee and Technical Working Group held at JCC on Tuesday, September 20, 2016 from 6 to 8 p.m. The recently hired consultant, Matrix Design Group presented an overview of the Joint Land Use Study and committee roles and process. Approximately 30 local officials and local leaders within a 30-mile radius of Fort Drum were in attendance. A group exercise was conducted to identify preliminary compatibility issues.

The Steering Committee is comprised of representation from: municipalities immediately adjacent to Fort, Drum, Fort Drum Garrison Commander, Fort Drum Director of Planning, Training, Mobilization, and Security, Fort Drum Director of Public Affairs, Fort Drum Regional Liaison Organization, Empire State Development.

The Technical Working Group is comprised of representation from: Jefferson, Lewis and St Lawrence county planning offices, City of Watertown planning office, Town of LeRay planner, NYS Tug Hill Commission, Tug Hill Tomorrow Land Trust, Cornell Cooperative Extension, ReEnergy, FDRLO, Fort Drum staff.

The Joint Land Use Study (JLUS) is a cooperative planning effort conducted as a joint venture between an active military installation, surrounding jurisdictions, state and federal agencies, and other affected stakeholders to address compatibility around military installations. The Fort Drum JLUS is funded by a grant from the Department of Defense Office of Economic Adjustments (OEA) and contributions by the JLUS sponsor, Development Authority of the North Country. The JLUS effort will directly benefit both Fort Drum and the surrounding region.

### Parks and Trails Grants Available

Parks & Trails New York (PTNY) and the NYS Office of Parks, Preservation and Historic Preservation (OPRHP), with support from Governor Cuomo and the NYS Legislature, are pleased to announce the second round of \$500,000 in competitive grants through the NYS Park and Trail Partnership Program funded through the NYS Environmental Protection Fund. The grants are available to Friends Groups of State parks and the program will be administered by PTNY, in partnership with OPRHP.

The program is designed to enhance the preservation, steward-ship, interpretation, maintenance and promotion of New York State parks, trails and state historic sites; increase the sustainability, effectiveness, productivity, volunteerism and fundraising capabilities of not-for-profit organizations that promote, maintain and support New York State parks, trails and state historic sites; and promote the tourism and economic development benefits of out-door recreation through the growth and expansion of a connected statewide network of parks, trails and greenways.

# The NY State Model Solar Energy Law for Local Planning and Zoning

Sustainable CUNY and the NY-Sun PV Trainers Network (PVTN) will host a webinar for jurisdictions interested in using the NY State Model Solar Energy Law and toolkit to update their zoning codes. This guidance tool kit was developed with support by the U.S. Department of Energy SunShot Initiative and is designed to assist New York communities in adopting zoning provisions that promote solar energy systems while protecting community character and the environment. The webinar will be Thursday, October 6 at 1:00 p.m.

The Model Law is intended as a straightforward approach and leaves more complicated, site-specific issues to be handled through existing land use processes, such as the State Environmental Quality Review Act (SEQRA) and Stormwater Pollution Prevention Plans (SPPPs). The authors aimed to balance best practices that promote solar with common local requirements and concerns. As such, the Model Law is presented as a practical, streamlined approach for facilitating solar energy systems in New York State. Many options for further promotion of solar energy systems are discussed in the comprehensive guidance attached to the Model Law, including directions for adopting and customizing the language and an appendix of additional considerations and resources. The Model Law and Toolkit was developed by Sustainable CUNY's NYSolar Smart Program's Planning and Zoning Working Group consisting of stakeholder jurisdictions and PACE Law School's Land Use Law Center. The Working Group consulted numerous stakeholders and completed a comprehensive review of zoning and planning best practices.
