Landowners Learn About Emerald Ash Borer

Representatives from NYS Department of Environmental Conservation (NYSDEC), National Grid, and the USDA - Animal and Plant Health Inspection Service (APHIS) were on hand to present information and answer questions Wednesday, August 17

in the Town of Lee. Approximately 25 interested landowners learned more about the insect's biology, prognosis for long-term impacts of ash tree death, and where they can go for assistance, as the insects are expected to spread from the recently found local infestation in Rome. The workshop was cosponsored by NYSDEC, Tug Hill Commission, and Tug Hill Tomorrow Land Trust.



A native of Asia, the insect was originally found in Detroit, Michigan in 2002. Since then it has spread across the northeastern US as it has no natural predators. Although purple prism traps continue to be deployed in the area to try and detect new infestations, observations by individuals is the best way to determine where the emerald ash borer may be.

Northern Border Grants Announced

Two projects in Tug Hill were awarded grant funds from the Northern Border Regional Commission in the 2016 grant round. The village of Lyons Falls will received over \$164,000 to extend water service to a new United Cerebral Palsy facility, which will bring in 18 jobs to the village. Additionally, Tug Hill Tomorrow Land Trust was awarded over \$248,000 for the purchase of an additional 604 acres of conservation easements on agricultural lands surrounding Fort Drum.
