## Big Turnout for "One for the Road" Workshop

Attorney Ken Ayers presented information about highways, roads and streets to an audience of over 170 local officials as well as DEC and DOT staff for four hours on Wednesday, June 29th at SUNY IT in Utica. The session was sponsored by the Tug Hill Commission, the SUNY IT Institute for Local Government, and the Local Government Education Committee of Oneida and Herkimer Counties. The workshop was moderated by NOC-COG Circuit Rider Gerry Ritter. The session began at 1:00 pm with a warm welcome from Deborah Tyksinski, Assistant VP, Director of Continuing Education at




SUNY IT. Tug Hill Commission Executive Director John Bartow made a few remarks relating to roads in the Tug Hill region and introduced Ken Ayers. For the next four hours, Ken covered the definitions for highways, roads, and streets; public highways vs. private roads; the history and background of turnpikes and plank roads; highways by dedication, eminent domain, and prescription; widths of highways; discontinuance and abandonment of highways; and answered a host of questions from the audience. A wealth of information was exchanged and the audience hopefully walked away with a better understanding about highways.

The workshop attracted 17 village officials, 84 town officials, 5 county officials and 36 representatives from NYS DOT and DEC. End-of-conference survey



results will be tabulated and shared with the cosponsoring agencies. Verbal comments as attendees left for the day were very positive. The NYS Department of Environmental Conservation (DEC) has funding available to help municipalities purchase equipment and help educate the public about the state's open burning policy, which strictly limits what people have traditionally burned on their properties. Projects eligible for grant funding include assisting communities in the purchase of equipment to manage residential organic waste materials that were previously disposed of by burning, as well as building community understanding of the dangers associated with open burning. **Examples of eligible purchases include vacuum leaf collectors, chipper/shredders and specialized composting equipment including grinders, windrow turners and bagging equipment.** The program will also fund outreach programs to educate residents about outdoor burning restrictions, the health and safety hazards of outdoor burning and safer ways to dispose of organic waste materials that were historically burned.

# FEMA's Assistance to Firefighters Grant

Now that the FY 2011 Federal budget has been approved, details for this year's AFG Program are available. The total FY 2011 appropriation for AFG is \$810 million. Of that amount, \$405 million will support fire and EMS operations and safety grants, firefighting and emergency vehicle grants, and fire prevention and safety grants and SAFER grants are supported at \$405 million. The projected schedule for application periods will be announced for each application period as soon as the grant guidance and application information becomes available. # Joint Infrastructure Management Initiative Update

Members of the JIMI group met on June 27th at the Dulles State Office Building. At the meeting, a status update was given on the project and next steps. Currently, the group is working through a VPN (remote access) issue, which will hopefully be fixed in the near future. After this issue is resolved, data collected during the project will be installed into the group's asset management software. Following data installation, the group will be gearing up for their 4 day, on-site asset management software training, followed by GPS training. The group will then begin the process of testing the full system. The goal is to have the full system fully functional by early fall.

# Dissolving or Consolidating? Three Things Local Governments Need to Know

Many local governments are considering dissolving or consolidating operations; some have already done so. If your local government is in this situation, please remember that the New York State and Local Retirement System (NYSLRS) and the Office of Local Government and School Accountability of the Office of the State Comptroller must be notified. To ensure a smooth transition, here is some important information to keep in mind.

#### • Outstanding Balance:

As with any other creditors, you may need to account for outstanding payments to the Retirement System. It is important to communicate with NYSLRS about payments owed on the annual invoice. Outstanding obligations may need to be transferred to the new entity.

### • Legal Documentation:

NYSLRS and Local Government and School Accountability will need legal documentation, such as a resolution, to verify that your municipality is dissolving or consolidating with another municipality.

#### • Retirement System Members:

If two governments are consolidating and the staff is merging, it is extremely important that you talk to the NYSLRS about retirement plans. As a result of the consolidation, the new merged entity or the existing one may need to make some changes to the plans available to their employees.

If a participating employer takes on the employees of a non-participating employer, any full-time permanent employees of the non-participating employer become mandatory members of the Retirement System and need to complete registration forms. Part-time employees of the non-participating employer have the option to join the System and must be offered membership.

Retirement System members may have many questions or concerns regarding the dissolution or merger of employers. It may be helpful to have an Information Representatives come speak to these members and explain how their pension benefits may be affected. NYSLRS understands the challenges dissolving or consolidating presents and is available to help make this transition a little easier on you and your employees. So, please let them know about your planned dissolution or consolidation by calling our Employer Participation & Education Unit at 518-474-0167.
