Over 680 local officials, speakers, and exhibitors attended the commission's 29<sup>th</sup> Annual Local Government Conference last week at Jefferson Community College, the largest conference of its kind in upstate New York. Elected and appointed officials from town and village governments in Jefferson, Lewis, Oneida, Oswego, St. Lawrence counties and beyond chose from 23 individual sessions on a wide variety of topics. In addition, 29 exhibitors displayed in the gymnasium highlighting a



wide variety of services. A keynote address by Regina Clark on "The Seven C's of Leadership" was well-received by the audience.

# **Local Leaders Survey In The Mail April 17**

The Tug Hill Commission's enabling legislation requires us to survey the region's local leaders every five years, to gauge our performance and gather input on future work. 2018 is the year, and surveys will soon be in the mail to over 350 village, town, and county officials, as well as many of our partner organizations. All survey responses are kept confidential. The responses will be combined into a white paper delivered to Governor Cuomo and the New York State Legislature later this year. Survey results will also be reported at local meetings of the Tug Hill Commission board and the region's councils of governments. The results will also be available on our website, www.tughill.org.

### Riparian Assessment Tool Available

The NYS Department of Environmental Conservation and the NY Natural Heritage Program have developed an online mapping tool to identify and prioritize riparian (stream) sites for restoration and protection. The assessment was funded by the Environmental Protection Fund and developed by NYNHP with guidance from DEC, the NYS Department of Agriculture and Markets, the NYS Department of State, The Nature Conservancy, and the Upper Susquehanna Coalition.

The new program includes user-friendly, interactive online mapping and analysis tools for viewing comprehensive information about sub-watersheds and smaller catchments within them throughout the state. Geographical data layers include indicators of ecological health and stress such as land use, forest canopy cover, water quality, impervious surface, and habitat for rare species. ## State Budget Passed; EFFI and State Land PILOT Payment Language Not Included

The 2018-19 NYS Budget passed at the end of last week, and two provisions that were of interest to Tug Hill communities were not included in the final bill language. One was the Empire Forests for the Future Initiative, which proposed a new forest tax law section 480b, among other things; and the other was a proposal to change the way NYS pays taxes to local jurisdictions on state owned land.

Commission staff will continue to monitor these proposals, as they could be resubmitted as stand-alone bills later in the legislative session.

### **Urban and Community Forestry Grants Workshop**

The New York State Department of Environmental Conservation (NYSDEC) is once again offering urban and community forestry grants in 2018. The purpose of the program is to assist communities in comprehensive planning, management, and education to create healthy urban and community forests, and enhance the quality of life through supporting activities including tree inventories and management plans; tree planting and maintenance.

DEC will be holding an information sessions aimed to assist potential applicants in preparation for the Round 14 Grant on Wednesday, April 11, 2018 from 10:00 a.m. until noon at the DeWitt Town Hall, 5400 Butternut Drive, East Syracuse, New York 13057.
