

## Minimum Maintenance Road Legislation 2019 Session Update

The 2019 NYS Legislative Session has ended, and while the long-standing minimum maintenance road legislation continued to be active, it was not passed by both houses.

The Senate bill, S2910 sponsored by Senator Griffo, was approved out of the Senate Transportation Committee with new chairman Senator Kennedy from Buffalo, and passed the Senate on June 13. The companion Assembly bill, A3724 sponsored by Assemblywoman Gunther, was referred to the Assembly Transportation Committee with new chairman Assemblyman Magnarelli from Syracuse. Although not reported out of committee, many meetings and discussions were held that improved communication and laid groundwork for next year's legislative session.

During the break between sessions, commission staff will continue discussions with partners and look for opportunities to explore forward movement on the issue.

# State Forest Action Plan Update Underway

The NYS Department of Environmental Conservation is working on update of the state's forest plan. Last completed in 2010, the plan is a strategic plan for New York's forestry community. The purpose of the plan is to provide long term, comprehensive, coordinated strategies to help the forestry community refine how it invests state, federal and leveraged partner resources in major management and landscape priorities.

Under the federal Farm Bill, every 10 years each state must submit a plan to the US Forest Service. The plan must be approved by the state's chief forester, who in New York is the director of DEC's Division of Lands and Forests. The next update of the Plan is due **June 2020**.

## SLELO PRISM Holds Invasive Species Symposium

SLELO PRISM (the St. Lawrence – Eastern Lake Ontario Partnership for Regional Invasive Species Management) recently conducted its invasive species symposium at the Tailwater Lodge in Altmar, New York. Symposium topics included managing invasive species in restoration projects, implications of climate change on invasive species, preparing your woods for the challenges of climate

change and invasive species, increasing resilience against invasives, a program to preserve native species' seeds for restoration efforts, and moving forward in resiliency and restoration in our work.

Ambassador Doug Barclay spoke about his efforts to preserve lands in the area in the face of invasives and land uses potentially detrimental to the area. Following the symposium, two field sessions were conducted on methods of seed collection, and identification and reporting of invasive species through the iMapInvasives program and web site (<a href="https://www.nyimapinvasives.org">www.nyimapinvasives.org</a>.)

## **Amish and Codes Training Well Attended**

A recent session hosted by the Local Government Education Committee in the town of Trenton relating to codes compliance and the Amish community was well attended. Representatives from the NYS Department of State Division of Local Government Services provided an overview of the Uniform Building Code, how communities can utilize zoning and comprehensive planning to protect farmland, and laws regarding farms and barn uses. Code issues identified as universally difficult to enforce included window sizes, CO and smoke detectors, workers compensation, and waste disposal. The session concluded with questions such as regulation of puppy mills, saw mills, and schools. The ultimate conclusion was that the Amish are technically subject to the same laws and enforcement as the rest of the population. ## **New Slow-Moving Vehicle Rules**

Effective June 26, 2019, farm machinery, implements of husbandry, agricultural tractors, and other machinery with a top speed greater than 25 mph and less than 40 mph must display a speed identification symbol reflecting its maximum speed, in addition to displaying the slow-moving vehicle emblem.

#### **Slow-Moving Vehicles**

Slow-Moving Vehicles (SMVs) are all vehicles that operate at 40 mph or less, including:

- ▲ Tractors
- Self-propelled farm equipment
- Road construction and maintenance machinery
- Animal-powered vehicles



Slow-Moving Vehicle Season

Motorists will encounter more agricultural slow-moving vehicles from late April through mid-October, when farmers are more apt to be planting and harvesting crops. Please be aware of these vehicles and use caution when sharing the road with them.



#### Slow-Moving Vehicle Emblem

- ▲ Effective June 26, 2019, farm machinery, implements of husbandry, agricultural tractors, and other machinery with a top speed greater than 25 mph and less than 40 mph must display a speed identification symbol reflecting its maximum speed, in addition to displaying the slow-moving vehicle emblem.
- NYS law requires vehicles that travel at 40 mph or less to have a Slow-Moving Vehicle Emblem:
  - Placed in the middle of the back end
  - Located two to six feet above the road
  - Kept clean and replace when faded
- Each piece of agricultural equipment, whether self-propelled or used in combination, shall separately display a slow-moving vehicle emblem
- It is illegal to put SMV emblems on stationary objects – such as mailboxes or driveway posts

#### Sharing the Road with Slow-Moving Vehicles

When motorists encounter a slow-moving vehicle on the roadway they should:

- Slow down immediately when you see a vehicle or equipment with a SMV emblem in the road
- Increase following distance to create a safety cushion
- Be alert and watch for turns into fields
- ▲ Drive courteously
- Pass with care only when it is safe and legal to do so
- Be aware that animal-powered vehicles may make unanticipiated movements
- Remember SMV operators may have poor visibility due to loads and equipment in tow
- Be aware that equipment in tow may sway on the road
