New Versions of Prior Written Notices, Successful Grants Checklist, and Tug Hill Sole Source Aquifers Papers Available

Commission staff has reviewed and updated two technical papers, *Prior Written Notices* and *Making Successful Grant Applications Checklis*t, and one issue paper, *Designation of the Northern Tug Hill Aquifer as a Sole Source Aquifer*. New version of these three documents are available at https://www.tughill.org/publications/technical-issue-papers/.

Prior Written Notices provides legal references and information that towns can use to help protect themselves from lawsuits due to dangerous conditions on town roads.

The Making Successful Grant Application Checklist includes how to:

- demonstrate a need for your project
- show that your project is well planned
- prove that your project has public support and has been property vetted
- accurately cost your project
- provide evidence of good management
- illustrate how the project will make a difference
- make your project attractive
- keep a positive attitude

Simply put, this event, on a day of your choosing in September or October, is meant to draw awareness to the problem of trash and pollution along our waterways. Emerald Ash Borer Continues to Spread

Emerald Ash Borer, an invasive insect from Asia that targets native North American ash species, continues to spread throughout the state. The NYS Department of Environmental Conservation recently updated the statewide map, available at https://www.dec.ny.gov/animals/7253.html and shown at right.

In Tug Hill, there are confirmed detections of EAB in Oneida and Oswego counties, but not Jefferson or Lewis counties at the current time.

Ash is a very common street tree in many New York communities. It was widely planted to replace native elms lost to Dutch elm disease. In Michigan, the first state in the U.S. infested with EAB, the greatest economic impact has been on communities faced with removal of thousands of dead ash on streets and in yards. Many of these dead trees

pose significant public safety hazards and liability problems for municipalities.

Ash is also a common and valuable forest species. Ash seeds are a food source for birds and mammals. Ash species (white, green and black) comprise almost 8% of all trees in NY State. Ash is a commercially-valuable species, and is used for baseball bats, flooring, furniture, lumber, and pallet manufacture.

NYSDEC Urban and Community Forestry Grant Information Sessions

The NYS Urban and Community Forestry program will be holding two information sessions locally in preparation for the Round 15 grant. The application for funding is expected to be available in Fall 2019. Project categories will include planting, maintenance, tree inventories, urban forest management plans and education programs. Developing Procurement Policies and Procedures

Every local government must adopt its own policies and procedures for procurements of goods and services not required by law to be competitively bid. Procurement policies and procedures generally ensure that competition is sought in a reasonable and cost effective manner for procurements below the bidding thresholds and for other contracts exempt from bidding. A procurement policy and procedures applies to:

- Purchase contracts involving expenditures of \$20,000 or less,
- Contracts for public work involving expenditures of \$35,000 or less and
- Professional services and other procurements not required by law to be competitively bid.

The law provides that goods and services not required to be competitively bid must be procured in a manner to assure the prudent and economical use of public moneys in the best interest of the taxpayers; to facilitate the acquisition of goods and services of maximum quality at the lowest possible cost; and, to guard against favoritism, improvidence, extravagance, fraud and corruption.

When a procurement is not subject to bidding requirements, the law generally requires that the procurement policy provide that alternative proposals or quotations be obtained by use of written requests for proposals (RFPs), written quotations, verbal quotations or any other method that furthers the purposes of the law.

Each locality should develop detailed procedures that are appropriate for the size and complexity of its operations. In adopting and carrying out a procurement policy and procedures, the benefits of required actions should not outweigh the costs, nor overburden the process. Additionally, the policy and procedures must require adequate documentation of actions taken; which may include written quotation forms, RFPs, and copies of Federal, State, county contracts or other government contracts for which "piggybacking" is permitted. If a contract is awarded to an offer other than the lowest dollar offer, the policy must require that there be justification and documentation, setting forth the reasons the award furthers the purposes of the statute.

Your policies and procedures should be reviewed annually, as required by law. This annual review can help ensure that procedures are current and appropriate to meet the changing needs of your local government. Comments from purchasing officials should be requested at review time, as they may identify the need to amend the policy or procedures.
