# NOCCOG Communities Begin GPS Mapping

Several municipalities in the Northern Oneida County Council of Governments (NOCCOG) have begun mapping infrastructure with GPS equipment purchased by NOCCOG to promote shared services. Tug Hill Commission staffer Mickey Dietrich recently provided training to local officials from the villages of Remsen, Camden, Holland Patent, and the town of Floyd. Paul Phister from the town of Lee assisted with the training, and will serve as the local resource for municipal staff when collecting data.

# Planning Board and ZBA Members Training August 19

The town of Osceola is hosting training for any interested Planning Board and ZBA members on Monday August 19<sup>th</sup> from 7:00 - 9:00 p.m. at the Osceola Town Hall/Library, 2117 North Osceola Rd., Osceola. The Tug Hill Commission's Director of Planning, Phil Street will be conduct the free training. If approved by your town or village board, this class would provide two hours of training toward the annual four hours required for planning and zoning board members.

### Salmon River Restoration Work

Approximately 1,500 linear feet of streambank on the Salmon River is being restored this summer by the NYS Department of Environmental Conservation (DEC), with toe wood installation and plantings in areas where the banks have eroded. Logs from the nearby Happy Valley Wildlife Management Areas are being used for material to tie into the banks, while fabric and plantings are installed on top. Additionally, "W" weirs are being built in the stream channel to create narrower, deeper areas of stream bottom to increase water flow in the center of the river and protect the banks from higher velocity flow. The projects are being funded by the Lake Ontario Sportfishing Restoration Natural Resource Damages fund and assisted by the U.S. Fish & Wildlife Service.





Another construction project is underway on State Route 13 near the county transfer station and DEC Environmental Conservation Officer academy. The new building, once complete, will store equipment and materials to support on-going sea lamprey control in the southeastern Lake Ontario watershed. The project is funded by the Great Lakes Fishery Commission. A new angler parking area will be built on the same site, to provide better access to Compactor Pool.

# "ZONING BOARD OF APPEALS OVERVIEW" And "LAND USE MORATORIA"



#### Division of Local Government Services

The Local Government Training program of New York Department of State is again partnering with the Lewis County Planning Department to present our annual land use training workshop. Local Government Specialists from Department of State will be training on the following course topics:

#### **Zoning Board of Appeals Overview (2 Hours)**

This introductory course to the Zoning Board of Appeals focuses on the statutory tests boards must follow to grant use and area variances and proper handling of the zoning interpretations. Meeting procedures and notice requirements will also be discussed, along with the ZBA's relationship with enforcement officials and the Planning Board, and the importance of making good findings.

#### Land Use Moratoria (2 Hours)

A moratorium is a local enactment that suspends a landowner's right to obtain development approvals while the local government considers changes to its regulations. Before enacting a moratorium, local officials should be aware of the circumstances in which a moratorium is the most appropriate action for a local government to take. This course looks at, among other things, the court cases that shaped the "rules" for adopting moratoria and the procedures local officials should follow in adopting moratorium laws.

# Oswego County to Spray Toad Harbor Swamp as EEE Detected

Oswego County has announced its intention to spray for mosquitoes in the Toad Harbor Swamp, from U.S. Route 11 and Central Square to the west, up to but not including the village of Cleveland to the east. Spraying will be south of State Route 49. The area to be sprayed is about 10,000 acres in portions of the towns of Hastings, West Monroe and Constantia.

EEE (Eastern Equine Encephalitis) has been detected in Toad Harbor Swamp and in area sampling stations. EEE is spread by mosquito bites, and can be fatal in humans and horses. A vaccine is available for horses; there is no human vaccine.



Spraying will begin sometime after 6:00 p.m. on Friday, August 16, weather permitting.

## **Brewerton Bridge Future Under Consideration**

The U.S. 11 bridge spanning the town of Cicero and the Tug Hill town of Hastings is under consideration for rehabilitation or replacement in the not-too-distant future. The New York State Department of Transportation conducted an open house on Monday, August 12 at Brewerton Elementary School at which they presented four alternatives to the baseline "Do Nothing" alternative.

The Brewerton Bridge was closed temporarily in 2014 when structural deficiencies were identified. It was reopened after repairs were effectuated.

Of the four alternatives to 'no action' identified, all would require one or two years to complete, and all called for the use of a temporary detour bridge while the bridge was closed. The current timeline calls for construction to commence in 2022.
