Commission Staff Assist with Grant Applications

Several organizations submitted grant applications for the July 26 Consolidated Funding Application deadline, with varying levels of assistance from commission staff.

- ⇒ The **town of Annsville** requested over \$245,000 from the Water Quality Improvement Program for a salt storage shed.
- ⇒ The *River Area Council of Governments/Village of West Carthage*, on behalf of 16 communities, requested over \$290,000 from the Local Government Efficiency program to support their LED lighting conversion project.
- ⇒ **Valley Snow Travelers** and **Winona Forest Recreation Association** each requested \$200,000 for new snowmobile trail groomers.
- ⇒ **Jefferson County** requested \$275,000 for a vacuum truck/street sweeper to support the Jefferson County Stormwater Coalition.
- ⇒ **Lewis County** requested \$50,000 from the Community Development Block Grant planning program to conduct a South Lewis Schools Reuse plan.

Funding announcements will be made late fall/early winter.

The examiners in the Deer River Wind Project's Article 10 Certification Proceeding (Case 16-F-0267) will hold public education and public statement hearing meetings on Tuesday, August 6, 2019 at the Lowville Academy & Central School District Auditorium at 7668 State Street, Lowville, NY 13367.

At the informational forum, the examiners will provide an overview of the Siting Board's certification process. Atlantic Wind will then present a brief summary of the proposed project and will have maps of the proposed project area available for viewing. Members of the public will then have an opportunity to pose questions about the process and the certification application pending before the Siting Board.

At the hearing, any person wishing to provide a public statement must complete a request card, and the examiners contact each person who has requested to provide a statement. Reasonable time limits may be set. Lengthy comments may be submitted in writing.

Tug Hill Commission and JCC Present Stream Sampling Findings August 14

SCI 199, "Interdisciplinary Science/Mathematics," is taught at Jefferson Community College (JCC) every spring. It was started by Pete Gaskin and Joel Lalone in 1994 with the goal of teaching about stream health, scientific sampling, and mathematical analysis. Students collect samples from local creeks and assess the streams using various techniques. They have collected data in the northwest part of Tug Hill and beyond, from Chaumont to Lowville to Sandy Creek. For several years, they worked with the Development Authority of the North Country (DANC) to sample Fish Creek, attempting to see if there was a significant difference downstream compared to upstream of the Rodman landfill.

This summer, JCC shared their data with the Tug Hill Commission, and intern John King has worked with the Tug Hill Commission staff and JCC professors to clean, analyze, and interpet the results. He will present information about the study's finding on **August 14**th **at 4:00 pm**, with time for questions at the end. A recording of the webinar will be made available on the Tug Hill Commission website. Financial support for John's internship at the commission has come from Jefferson County's "The Workplace" Summer Youth Employment Program.

Port Leyden Community Brainstorm Well Attended

Over 50 people attended a community brainstorming session in Port Leyden on Tuesday July 30. At the request of Port Leyden Mayor Heather Collins, commission staff partnered with Lewis County agencies to collect feedback from Port Leyden residents on issues in their community, ideas to address those issues, and wish list items for the future. The evening's results will be shared with the village board in a report over the next few months, and partner organizations will discuss how to move forward with implementation items.

LED Streetlights Conversion Project

The River Area Council of Government (RACOG) LED streetlight conversion project has grown to communities outside RACOG and the Tug Hill region, with 16 municipalities participating in a project that will cut costs across the area.

The group has focused on a municipally owned option and has elected to go with the New York Power Authority (NYPA) for an aggregated LED conversion. The estimated yearly savings is \$211,164.95. The group is also looking to utilize smart controls for remote monitoring and maintenance as an asset management tool, which will also provide greater control of each individual light fixture. Smart control systems will also provide the capability to add advanced sensors. Examples of advanced sensors include water meter readers, increased Wi-Fi accessibility, temperature and humidity, vibration, or air quality monitoring.

A design study will be done by Wendel Architecture & Engineering, consultant for NYPA, to assess each individual municipality to determine lighting needs, as well as what advanced sensors might be worth adding to a smart control system.

Due to the group's interest in smart controls and to offset project costs, the commission assisted with a Consolidated Funding Application (CFA) submitted last week through the Local Government Efficiency Grant (LGEG) program for smart control purchase. The village of West Carthage took the lead on the CFA, on behalf of the 16 municipalities.

August Single-Session Monitoring and Managing Ash (MaMA) Training Workshops August 3, 5, 6

The MaMA program of the Ecological Research Institute (see www.MonitoringAsh.org) provides constructive actions to take at each stage of Emerald Ash Borer (EAB) invasion, including even pre-invasion and the final invasion stage. In this **free** workshop, you'll learn how to mitigate EAB damage and to detect naturally occurring EAB-resistant native ash, which provide great hope for ash conservation. You'll learn how to use MaMA's citizen-science projects, including the MaMA Monitoring Plots Network, which reaches from New England to the Midwest, and the MaMA Lingering Ash Search project, in which you report locations of trees that are likely EAB-resistant.
