Local Government Innovation Conference October 18

The NYS Department of State is holding their fifth annual Local Government Innovation Conference on Friday, October 18, 2019 at the Empire State Plaza in Albany. Two plenary sessions are entitled "Cyberattack: is YOUR municipality next?" and "Fighting Blight: Community Officials Data Exchange." After lunch, two tracks will share examples of what communities have done in water and wastewater infrastructure and technology/shared services; and will show tools, including DOS's Geographic Information Gateway and programs/strategies to support rural economic development and resiliency.

Land Trust Receives Over \$2 million to Protect Over 1400 Acres of Farmland

Tug Hill Tomorrow Land Trust is receiving over \$2 million from the NYS Department of Agriculture and Markets to purchase conservation easements on four farms. The funds will ensure the land remains used for agricultural purposes, and may help farms to diversify or transition operations to the next generation.

The four projects are:

- \$417,690 to protect 236 acres of Groeslon Farm in the town of Remsen, Oneida County
- \$468,878 to protect 323 acres of Northrup & Sons Farm, towns of Adams and Rodman, Jefferson County
- \$301,184 to protect 156 acres of Nemeth Farm, town of Martinsburg
- 880,678 to protect 721 acres of Huntley Farm in the town of town of Pierrepoint, St. Lawrence County

Climate Leadership and Community Protection Act Discussed at ANCA Annual Meeting

New York State's Climate Leadership and Community Protection Act (CLCPA) was signed into law in July of 2019, and presenters Amanda Lefton, First Assistant Secretary for Energy and the Environment and Mark Lowery, with NYS Department of Environmental Conservation's Office of Climate Change, discussed its provisions at the Adirondack North Country Association's (ANCA) annual meeting Friday, September 20.

The CLCPA goes into effect on January 1, 2020 and includes the following goals:

- By 2025, 6 gigawatts of distributed solar installed
- By 2025, 185 Tbtu of onsite energy savings
- By 2030 renewable energy systems account for 70% of statewide electricity generation
- By 2030, greenhouse gas emission reduced by 40% from 1990 levels, to include the entire energy economy (transportation, buildings, electricity generation)
- By 2030, 3000 megawatts of energy storage installed
- By 2035, 900 gigawatts of offshore wind installed
- By 2040, a carbon free electricity generation system
- By 2050, greenhouse gas emissions reduced by 85% from 1990 levels

The CLCPA also creates the first statutory Climate Action Council, and several advisory panels by topical area:

- Transportation
- · Land use and local government
- Housing and energy efficiency
- Energy intensive industries
- Power generation
- Agriculture and forestry

There will be an emphasis on environmental justice communities throughout the process.

NYS Discretionary Grant Program for the Conservation and Preservation of Library Research Materials

The New York State Program for the Conservation and Preservation of Library Research Materials provides \$500,000 each year for preserving materials in the collections of libraries, archives, historical societies and similar agencies. The grant awards for 2020-2021 will be limited to a minimum of \$2,500 and a maximum of \$40,000. **Deadline: November 8, 2019**. Town Budget Workshop Held in Altmar

The Tug Hill Commission organized a workshop conducted by representatives of the Office of the State Comptroller at the Albion Municipal Building in Altmar on Wednesday, August 28, 2019. The well-attended workshop drew nineteen attendees spanning three counties and nine different municipalities. The presenters Laird Petrie and Heidi Rosen, covered budget preparation, fund balances, and the use of the town budget as a financial management tool.



Preservation Assistance Grants Available for Smaller Institutions

The National Endowment for the Humanities anticipates grants being available on November 15, 2019. These grants help small and mid-sized institutions (such as libraries, museums, historical societies, archival repositories, cultural organizations, town and county records offices, and colleges and universities) improve their ability to preserve and care for their significant humanities collections. These may include special collections of books and journals, archives and manuscripts, prints and photographs, moving images, sound recordings, architectural and cartographic records, decorative and fine art objects, textiles, archaeological and ethnographic artifacts, furniture, historical objects, and digital materials.

The maximum award amount is \$10,000 or \$15,000 for projects related to the 250th anniversary of American independence. Applications are expected to be due on January 15, 2020, with notifications of awards on August 31, 2020.
