Registration and session information for the March 26, 2020 Local Government Conference (LGC) is now available on our website. You'll find everything you need including session topics and registration information. ALSO, please watch your mailboxes, as the registration and session information will be mailed out by the first of the year. There are options for on-line and in the mail registration, and we have kept our regular registration rate low at \$50 if post-marked by March 6.

Registration starts at 7:30 am, and the day kicks off with a short keynote at 8:30 am, followed by four separate sessions throughout the day and lunch in the gymnasium. At 4:00 pm, everyone is invited to a reception for an opportunity to catch up with friends and colleagues before you head home!

Each of the four sessions will include seven individual presentations for you to choose from. Our goal is to include a variety of subjects in each session that would be useful for a variety of local officials including highway staff, clerks, town and village board, planning board, and zoning board of appeal members and assessors.

Session one topics include: Employee Handbook Basics, All About Grant Preparedness, Site Plan and Subdivision Review, Spot Zoning, Right-sizing Culverts, Vital Records and The Climate Leadership and Community Protection Act.

Session two topics include: Reserve Funds and Long-Term Planning, Cyber Threat Mitigation, Historic Preservation, Transparency in Planning Proceedings, Municipal Rights of Way, Your Role in a Disaster, and PILOTs for Renewable Energy.

Session three topics include: The EMS Crisis and Its Impact on Municipal Budgets, Small Wireless Facilities and 5G in New York State, Translating Comprehensive Plans in the Face of Live Projects, Land Use and SEQR Case Law Update, Selecting Pavement Preservation Techniques, and Climate Smart Communities.

Session four topics include: Social Media and the First Amendment, River Restoration and Resiliency, Ethical Considerations for Planning Boards and Zoning Boards of Appeal, Q&A for Planning and Zoning Boards, Myths of Traffic Calming and Complete Streets, Email Essentials and Siting Utility Scale Solar Projects.

NYS Department of Agriculture and Markets, Companion Animal Capital Fund

This fund was created to enable eligible organizations to upgrade their facilities to promote better animal care and health and to encourage pet adoption.

Grants can be used to construct, renovate, rehab or acquire buildings and equipment needed to house, treat and care for sheltered dogs and cats.

- Eligibility: Municipal and incorporated not-for-profit shelters, humane societies, and societies for the prevention of cruelty to animals are eligible applicants.
- ♦ Funding: \$5 million
- ◆ Deadline: January 21, 2020, by 4:00 p.m.

The first of these articles reported on a tour commissioners and staff took of Black River Valley Natural in Lyons Falls, Lewis County. This week we are just outside the region in Jefferson County.

Agbotic Greenhouses in Sackets Harbor Operational

Staff recently toured the Agbotic Greenhouses in Sackets Harbor. After several years of design and testing, six automated, data-driven, and machine learning greenhouses are up and running in the village of Sackets Harbor. Agbotic (www.agbotic.com) is now growing certified organic radish and beet greens, marketed under the "GoodHealthy" brand (www.GoodHealthy.com), for sale throughout the North Country and into greater NYC markets.



Agbotic recently announced a joint effort with Black & Veatch to optimize, standardize, and turn-key deliver the Agbotic Smart Farm model co-located with sustainable energy assets (https://finance.yahoo.com/news/agbotic-black-veatch-announce-collaboration-232900705.html). As Agbotic looks to replicate their business model in other areas, potential sites should be either organic farmland or farmland that can easily be certified organic and have access to three-phase power, public water, and sewer. A natural gas service is preferred but not required, particularly as the company looks to increase the use of solar and geothermal technologies.
