## New Tug Hill Regional Map Brochure Available for Download

The Tug Hill Commission has published a new version of its *Tug Hill Regional Map*, available online at <a href="mailto:tughill.org/about/what-is-the-tug-hill-commission/">tughill.org/about/what-is-the-tug-hill-commission/</a>. Printed copies will not be immediately available, but the document can be downloaded and printed, or viewed as a flipbook on the commission's website.

The map and accompany text were last updated in 2012. The map brochure is used for a variety of purposes, including:

- 1. Introducing the public to the Tug Hill region's geography, natural resources, economy, recreational opportunities, and energy profile;
- 2. Presenting the Tug Hill Commission and its mission;
- 3. Showing essential features of the region, such as the regional boundary, the municipalities' boundaries, and destinations—especially forested areas;
- 4. Illustrating the character and highlights of the region; and
- 5. Underscoring the importance of our region in New York State.

# **Executive Order Extends Period Allowing Non-In-Person Municipal Meetings**

As interpreted by the Committee on Open Government (www.dos.ny.gov/coog/), Executive Order 202.34, issued May 29, 2020, extends Executive Orders 202.14, 202.28 and 202.31 and with that, municipalities may continue to meet by means other than in person, with certain stipulations as previously established.

Executive Order 202.34 contains "directives for the period from the date of this Executive Order through June 27, 2020", and its specific extension of previous Executive Order 202.31 "is hereby continued until and unless later amended or extended by a future Executive Order."

#### Local Governments and COVID-19: An Overview

As regions across NYS move through the four reopening phases, local governments have questions on what applies to them and how they should conduct business going forward. The commission has tried to compile as much relevant information as possible for you to consider as reopening continues to progress through the phases. Additionally, NYCOM is preparing guidance for municipalities and that will be shared once available.

- Local governments are considered essential and were never "closed" by the Governor's executive orders. Local governments were required to deem which employees and services were "essential" versus "non-essential." For many towns and villages, that meant closing offices and performing office-based tasks remotely and shifting infrastructure-related employees to staggered work schedules, for example.
- With many municipal offices beginning to reopen, guidance from **Empire State Development** states: "Municipal government operations should practice physical distancing and telecommuting as much as possible, however it is up to the individual municipality how they determine which functions are essential. All local governments are operating at a maximum of 50% in-person workforce presence." esd.ny.gov/nyforward-faq
- Regarding face masks, NYS Department of Health guidance states "Essential businesses, as well as state and local government agencies and authorities, must procure, fashion, or otherwise obtain face coverings and provide such coverings to employees who directly interact with the public during the course of their work at no-cost to the employee." coronavirus.health.ny.gov/system/files/documents/2020/04/doh covid19 eo20216employeefacecovering 041420.pdf
- Pursuant to Executive Order 202.10 all non-essential gatherings of individuals of any size for any reasons (e.g. parties, celebrations, or other social events) are canceled or postponed. However, Executive Orders 202.32 and 202.33, issued subsequently, allow ten or fewer people to gather for any lawful purpose or reason, provided that social distancing protocols and cleaning and disinfection protocols required by the Department of Health are adhered to. <a href="essenting-essentive-order-2026">esd.ny.gov/</a>

- Executive Order 202.34 authorizes businesses to deny entry to individuals who do not wear masks or face-coverings.
- Examples of practices being used by some local governments include:
  - 1. Develop a reopening plan using the template provided by NYS, <a href="www.governor.ny.gov/sites/governor.ny.gov/files/">www.governor.ny.gov/sites/governor.ny.gov/files/</a> <a href="mailto:atoms/files/NYS">atoms/files/NYS</a> <a href="mailto:BusinessReopeningSafetyPlanTemplate.pdf">BusinessReopeningSafetyPlanTemplate.pdf</a>.
  - 2. "By appointment only" for the public that needs to do business with the municipality.
  - 3. Have a mail drop for paperwork that needs to be delivered to the municipality.
  - 4. Designate doors as enter and exit only to minimize people coming into contact.
  - 5. Mark areas on floor six feet apart where needed, have seats in meeting rooms six feet apart.
  - 6. Make hand sanitizer available for staff and visitors.
  - 7. Offer a remote component to your board meetings, even if most are meeting in-person. The commission can help you hold a hybrid Zoom and in-person meeting.

#### **Commission Fosters Collaboration in Broadband Research**

Broadband coverage on Tug Hill has been a topic of discussion for many years at the commission. Recognizing the need for improved connectivity in our communities, a collaboration began in 2015 with the Cooperative Tug Hill Council to survey internet service in the towns of Rodman, Harrisburg, and Turin. Respondents indicated that 83% had internet service, but 72% of those households were un-



satisfied with their service. Of the 17% without internet service, the top three reasons for being unserved were: affordability, unsatisfactory internet service, and a feeling that they do not need internet.

With the outbreak of the COVID-19 pandemic, the issues with broadband on Tug Hill have been elevated. Areas of greatest concern are households, especially low-income households, with children K through 12 attending school virtually, households of persons with telehealth needs, and households with people teleworking.


Fortunately, a task force—New Upstate Cellular Coverage Task Force—was created to understand coverage in Upstate NY, and a program—the New NY Broadband Program—was created to distribute grants across the state. Several of these grants have been awarded in recent years to providers to extend their coverage into unserved and underserved communities on Tug Hill. There is also a plan titled "Charter Communications' NYS Broadband Expansion Plan" that was created when Charter (i.e., Spectrum) took over Time Warner Cable in NYS. Local officials can request coverage maps for their municipalities, which requires signing a non-disclosure agreement.

It is generally agreed that the broadband coverage mapping resources that do exist, publicly, are flawed or limited. In order to better understand the needs in our Region, especially for broadband build out, the commission will partner with the Development Authority of the North Country, Syracuse University, Cornell University, and Fort Drum Regional Health Planning Organization to conduct research on broadband coverage in the Tug Hill Region as a whole.

This research will assist in identifying unserved and underserved communities to better service their needs. Key areas that will be studied are accessibility to service, affordability of service, and quality of throughput. Three important service areas that will be highlighted in this project are broadband for education in the home, telehealth, and public safety.

The information gathered throughout this project will be used to recommend short-term and longer-term innovative and cost-effective solutions, streamline municipal regulations, and apply for grants in unserved and underserved communities. #### **Tug Hill Tomorrow Land Trust Conducts Community Survey**



The Tug Hill Tomorrow Land Trust's 30<sup>th</sup> anniversary is approaching, and the land trust is reaching out to the larger Tug Hill community to hear what conservation work and programs are desired moving forward.

Over the past 30 years, the land trust has conserved over 20,000 acres of working farms, forests, and wildlands through 105 permanent, voluntary conservation agreements. They also own one public conservation area with trails and have assisted other communities to create trails of their own.

# Public Service Commission Notice on Renewable Energy Facility Host Community Benefit Program, Comments Due July 3

As part of the Accelerated Renewables law, the NYS Public Service Commission is required to develop a host community benefit program. A draft of the program's structure has been released, with comments due by July 3, 2020. The major components are:

- The program will apply to renewable energy projects greater than 25 MW (nameplate generating capacity).
- The renewable energy developers will fund a benefit for electric distribution to customers located in the municipalities that host their project.
- The benefits can be a bill discount, a credit, or a compensatory or environmental benefit for impacted electric utility consumers
- Some of the factors affecting the amount of benefits are the average electrical output of the facility, the average number of customers, and the impact on environmental justice communities.

# American Farmland Trust Releases New Report on Farmland

American Farmland Trust (AFT) has a new report out entitled <u>Farms Under Threat: The State of the</u>

States. Farms Under Threat is AFT's multi-year initiative to document the status of and threats to

America's agricultural land while at the same time offering policy solutions to save that land. *The State of the States* paints a striking picture of the threats facing agriculture and documents the steps every state has taken to protect and retain their agricultural land base for working farms and ranches.

Along with the report, maps and policy findings are available on an <u>interactive website</u> with additional resources, such as summaries for each state to highlight the findings from AFT's mapping and policy analyses.

New York's AFT office held a webinar on June 3<sup>rd</sup> for an in-depth look at the findings and an overview of the tools now available to help planners, land protection practitioners, policymakers and advocates strengthen and expand agricultural land retention and protection efforts in New York. # **DEC Invites Public Comment on Draft Trout Stream Management Plan**

The NYS Department of Environmental Conservation (DEC) is seeking angler feedback on a proposed plan to manage trout in inland streams. The proposed changes are designed to safeguard wild trout and expand fishing opportunities. The deadline for the public to comment on the draft plan is **June 25, 2020.** Interested anglers and communities in the Tug Hill region can review and share their comments at: <a href="https://www.dec.ny.gov/outdoor/111015.html">https://www.dec.ny.gov/outdoor/111015.html</a>, and by emailing <a href="mailto:trout@dec.ny.gov">trout@dec.ny.gov</a>.

Major elements of the draft plan include: drawing a clear line between wild fish and stocked trout management; placing greater emphasis on habitat improvement; making management simpler and more understandable; eliminating unnecessary regulations; providing year-round fishing opportunities through the creation of a statewide catch-and release season; extending the duration of stocking on select stream reaches; increasing the size of stocked fish; ensuring that each stocking contains some fish that are 12 inches or larger; improving the vigor of hatchery brown trout for increased survival; developing an interactive map for information on stream reach management and fishing access locations; and expanding outreach on the significance of wild trout populations and the water they inhabit.
