The Constable Chronicles series looks at the Constable Family and Constable Hall, Jewel of the North Country, from a personal perspective with facts, some fiction, and family lore. Narrator Martha Constable Murray, a direct descendant of William Constable Jr., the builder of Constable Hall, will have all the details plus a look at how laundry was done and how butter was made. Planning and Zoning Board Training Sessions October 27 and 29

Attorneys Jim Burrows and Dave Geurtsen from Conboy, McKay, Bachman and Kendall, LLP will be presenting "Renewable Energy and Land Use" on Tuesday, October 27 from 7:00 p.m. to 9:00 p.m. at the Town of Watertown Municipal Building, 22867 County Route 67, Watertown, NY 13601. The presentation will provide a comprehensive overview of the regulatory environment regarding renewable energy projects. Ranging from local zoning laws to Article 10 to the new Office of Renewable Energy Siting proposed regulations, the session will explore the role of local government in regulating land use. We will discuss best practices for running meetings and public hearings in the context of NYS Open Meetings Law. A brief discussion of SEQR and county planning review will also be included. Early History of the Black River

Peter Hayes, Constable Hall & Dr. Laurie Rush, Ft. Drum Cultural Resources

Dr. Rush will introduce the history of the Black River from an indigenous perspective, examining its importance as a key waterway connecting peoples of the Eastern Seaboard and the Maritimes with peoples of the Midwest and the Great Lakes. She will also touch on some of Jefferson County's earliest and most important European settlers and developers. Mr. Hayes will discuss the transition of land ownership from the Treaty to Fort Stanwix to the Macomb Purchase. Emphasis will be given to William Constable's role in the purchase, survey and initial selling of the land. The early development of the land will be illustrated by the efforts of William Constable Jr., James LeRay de Chaumont, and Hezekiah Pierrepont – who collectively left us Constable Hall, the LeRay Mansion and the Pierrepont Manor.

Dr. Laurie Rush is the Cultural Resources Manager and Army Archaeologist at Fort Drum. She also serves as the diplomatic liaison between the 10th Mountain Division and Fort Drum and the Oneida Indian Nation, the Onondaga Nation and the St. Regis Mohawk Tribe. She has lived and worked in the region since 1983 studying indigenous people of the eastern Great Lakes as well as the stories and history of the towns and villages. Peter Hayes is the Curator at Constable Hall. Peter grew up in Constableville and then completed a 40-year career working in electrical and computer engineering for small technology companies. He recently retired and lives part time in his old Constableville homestead. In addition to being the curator at the Hall, Peter pursues other hobbies such as gardening and interesting (to him) technology projects.

Public Meetings and Hearing with COVID-19 Webinar October 14

The Jefferson County Planning Department and the NYS Department of State are offering a online webinar "Public Meetings and Hearings with COVID-19" on Wednesday, October 14 from 6:00 p.m. to 8:00 p.m. The session will address the goals and requirements associated with holding meetings, in contrast to the purposes and legal requirements surrounding a public hearing. It will explore the role of the chairperson in conducting effective meetings and hearings and include a discussion of how to manage the public and the media in the context of a hearing or meeting. Also addressed are aspects of the Open Meetings Law, including executive sessions, quorums, minutes, and public notices.

The session speakers are Paula Gilbert and Ebony Map, Local Government Specialists with the NYS Department of State Division of Local Government Services.

Martinsburg Fire District Map

The town of Martinsburg requested that a map be made for the two fire districts within the town. The map will assist first responders and firefighters with their emergency duties. The commission provides mapping services to all Tug Hill communities, free of charge. RACOG LED Lighting Project Progress

Design studies have been completed for all participating communities in the New York Power Authority (NYPA) LED street lighting project being spearheaded by the River Area Council of Governments. Some communities have already voted on whether to move forward with the project, with others making decisions this month. The project received a Local Government Efficiency grant award of \$291,000 toward asset management controls for their lighting, making them Smart City ready. Each community also can receive a \$20,000 grant from NYPA for Smart City technology, with no match required. NYPA will also match up to 50% after the initial \$20,000. The limit of matching dollars is dependent on number of lights. Each community should also be eligible for a National Grid incentive, as long as funds are available. The project is being highlighted as a shared service project, with 16 communities in two counties participating in the original grant application.

Assistance to Firefighters Grant-COVID-19 Supplemental Round 2 Application Period Open

FEMA is providing a second opportunity for <u>volunteer and combination fire departments</u> to apply for funding under the Fiscal Year 2020 Assistance to Firefighters Grant Program – COVID 19 Supplemental. Through this AFG-S Round 2 funding opportunity, FEMA will directly award funding for personal protective equipment (PPE) and other supplies to support coronavirus (COVID-19) response. This includes reimbursement for applicable PPE expenditures made since Jan. 1, 2020. Grants will be awarded, using a competitive process, to applicants whose requests best address the priorities of the AFG-S grant opportunity.

The Notice of Funding Opportunity (NOFO) is available for \$31 million in funding for the Fiscal Year 2020 Assistance to Firefighters Grant – COVID-19 Supplemental Program (AFG-S) to help provide personal protective equipment to firefighters and first responders who are managing emergencies during the COVID-19 pandemic.

The application period will close at 5 p.m. ET on Nov. 13, 2020. The Assistance to Firefighters Grant Program Office has developed tools to help potential applicants plan their AFG-S applications. These tools, such as a calculator that can help you understand and determine your organization's cost share for AFG-S grants, can be viewed on the AFGP website at FY 2020 AFG-S COVID-19 Guidance Documents and/or downloaded to your computer.

Key Questions about the FY20 AFG-S Round 2 application:

Why are only volunteer and combination fire departments eligible in round 2?

By law, 25 percent of available AFG-S funds must be awarded to volunteer fire departments and another 25 percent must be awarded to combination fire departments. This second application period will be limited to those categories of fire departments to fulfill this requirement.

Can my department apply again?

Volunteer and combination fire departments are eligible to apply in the FY20 AFG-S Round 2 even if they were awarded a grant under the first application period of the FY20 AFG-S. However, such applications must support new capabilities. Departments that applied in the first application period but were unsuccessful must reapply to be considered for funding in this second application period. Applications from the first application period will not automatically carry forward to Round 2 for automatic consideration.

State Comptroller Announces Tax Levy Limit for 2021 Town Budgets

State Comptroller Thomas DiNapoli has announced the tax levy limit for local government units whose fiscal years end December 31. These local governments, which include towns and counties, will have a tax levy limit of +1.56% for the 2021 fiscal year.
