## Lake-Effect Electrification Study Underway; Sensors Installed Across the Region

The Lake-Effect Electrification and the Impacts of Wind Turbines on Electrification East of Lake Ontario study, referred to as LEE, is underway. Funded by a \$1 million National Science Foundation grant, SUNY Oswego is partnering with the University of Oklahoma and the National Severe Storms Laboratory (NSSL) to research the problem of lake-effect lightning striking and damaging local wind farms. Solar-powered, portable Lightning Mapping Array sensors have been installed across the Tug Hill region and will collect lightning related data. NSSL researchers are also using instrumented balloons to collect storm electricity data as they rise into the storm. The project also includes a Doppler on Wheels mobile unit on loan from the University of Illinois.

SUNY Oswego Professor Scott Steiger is providing real-time updates on the project on a Twitter account, @nsf\_lee, and will present about the project at the Tug Hill Local Government Conference on April 6, 2023 at Turning Stone Event Center.

## **Community Development Block Grants Announced for Constantia, Orwell**

Governor Kathy Hochul announced more than \$33 million in Community Block Grant awards Tuesday, November 15, and \$2.5 million is designated for the Tug Hill region via state Homes and Community Development.

The town of Constantia is to receive \$1.25 million toward the cost of developing sewers in the Constantia-Bernhards Bay Sewer District. The district, on the north shore of Oneida Lake, has a significant number of old and failing septic systems, many of which are inadequate for more intensive demands placed on them since their original installation.

The town of Orwell was awarded \$1.25 million for improvements to their public water system. In recent years, the system has periodically experienced water shortages, boil water advisories, and high nitrate warnings, and the town has been actively pursuing options to remedy these problems.

### Final Updated Tug Hill Regional Maps Delivered

Last week, the Tug Hill Commission concluded delivering updated regional maps to the remaining municipalities within the Tug Hill region. Every municipality within the Tug Hill region should now have the updated regional Tug Hill map with their municipality highlighted, suitable for hanging on a wall if desired.

The map displays the different areas across Tug Hill by highlighting the locations of state forests, state wildlife management areas, state parks, county and municipal parks, and water features such as streams and lakes. In addition, the map features basic infrastructure such as roads and railroads. The area around Tug Hill is displayed in less detail but includes Fort Drum, the border of the Adirondack Park, and various municipalities. The map stands to be used as a visual aide for each respective municipality and the various municipal boards across Tug Hill to help better visualize the location of natural resources and important infrastructure.

#### **RACOG Digital Radar Sign Presentation**

At the October 26 River Area Council of Governments meeting, Chris Paginello from Traffic Systems, Inc. did a demonstration of digital radar signs for interested member communities. Chris's presentation included both the solar powered permanent sign and battery-operated mobile sign. The signs can collect data on what day and time people are speeding through an area, which could allow law enforcement to be more efficient in setting up radar traps. The goal of the communities interested in the digital radar signs is to improve pedestrian safety on their roads. There are studies that show having these alert systems will typically slow people down 80% of the time.

The storm ripped the steeple off the Presbyterian church, damaged homes, and destroyed hundreds of trees. This locally produced documentary tells the story of damage and rebuilding and describes how this hardship brought residents together.

# **Updated Local Law Required for Enforcing Uniform Fire Prevention and Building Code**

The NYS Department of State has filed a Notice of Adoption of a rule repealing and replacing Part 1203 of Title 19 of the New York Codes, Rules and Regulations. Under Executive Law § 381(1) the Department of State is authorized to promulgate regulations establishing minimum standards for administration and enforcement of the Uniform Fire Prevention and Building Code (Uniform Code). Additionally, Energy Law § 11-107 provides that the Energy Code shall be administered and enforced in the manner prescribed by applicable local law or ordinance consistent with the standards and procedures adopted pursuant to § 381 of Executive Law.

Executive Law § 381(2) provides that local governments (cities, towns, and villages and, under some circumstances, counties) are required to administer and enforce the Uniform Code. 19 NYCRR Part 1203 contains the "minimum standards" established by the Department of State pursuant to Executive Law § 381(1) and requires each local government that administers and enforces the Uniform Code and Energy Code to establish a code enforcement program and to include certain features within that program.

Based on the new versions of the Uniform Code and Energy Code effective since May of 2020, corresponding changes were necessary to 19 NYCRR Part 1203 to coordinate these rules and regulations for administration and enforcement of the Uniform Code and Energy Code.

This means that local governments will have until December 30, 2022 to update their code enforcement programs by local law, ordinance, or other appropriate regulation. An updated model local law is available on the <u>Department of State's</u> website as well as full text of the <u>amended rule</u>.

### ANCA Webinar Series, NYSERDA "Overview of the Model Solar Law"

The Adirondack North County Association (ANCA) recently hosted a webinar in cooperation with <a href="NYSERDA">NYSERDA</a> titled "Overview of the Model Solar Law." The speaker was Bill Oberkehr, a senior project manager at NYSERDA, working within the Clean Energy Siting space.

The webinar focused primarily on photovoltaic (PV) solar projects, but mentioned there are two other types of solar: focused solar which positions mirrors to focus on a single point, and thermal solar which captures the heat energy from the sun. They referenced the requirements of the "Climate Leadership and Community Protection Act," otherwise known as the Climate Act, which is the NYS law mandating 70% renewable energy by 2030 and 100% projects.

The main purpose of the presentation was to continue to demonstrate the classifications and regulations on solar development that will be coming in the future, and how municipalities can prepare their local laws to site the solar projects in the best place for each municipality and its citizens.
