Sandy Creeks Stakeholder Meeting January 17

Do you live or work in the towns of Adams, Ellisburg, Lorraine, Rodman, Worth, Sandy Creek, Boylston or Richland? We need your input!

Jefferson County and Oswego County Soil & Water Conservation Districts, NYS Tug Hill Commission, and Upstate Fresh Water Institute are working together to develop a 9-Element (9E) Watershed Management Plan for the Sandy Creeks Watershed. The 9E Plan will identify water quality concerns, priority areas for water quality sampling, and strategies for addressing water quality concerns. The plan will be beneficial to municipalities and anyone seeking grant funds to improve water quality in this area. View an interactive map of the target watershed here.

Oneida Lake Watershed Public Meeting January 24

A public meeting will be held on Tuesday, January 24, 2023, at 7:00 p.m. to garner input on the Oneida Lake Nine Element Watershed Management Plan. When complete, the plan will describe the community's water quality concerns and provide a strategy to address those concerns. This plan will be developed in partnership with people who live, work, visit, and enjoy Oneida Lake, its tributaries, and the greater watershed, with guidance from state and local agencies.

Madison County has received funding for the plan from the NYS Department of State with support from the Central New York Regional Planning and Development Board and in cooperation with a watershed advisory committee. 2023-2024 Records Management Grant Guidelines Released

New York State Archives has announced that the guidelines for the 2023-2024 Local Government Records Management Improvement Fund (LGRMIF) grant cycle have been released in advance of the application portal and are available now. The eGrants portal will open on **January 4**, **2023**, and applications may not be created, edited, or submitted in the portal before that date.

The Local Government Records Management Improvement Fund provides grants to local governments. These grants assist local governments to establish records management programs or develop new program components. It is a competitive program, awarding grants based on the merits of applications.

If you plan to apply for an LGRMIF grant, your Records Management Officer (RMO) must have a NYS Directory Service (NYSDS) account by **February 15, 2023**. If you do not have a NYSDS account, please complete the **online registration form**. If you are not sure if your RMO has an account, email **archgrants@nysed.gov**.

The 2023-2024 application due date will be **March 1, 2023**. For more information, and to access the Guidelines, please visit our **LGRMIF webpage**.

Commission Assisting Adoption of CTHC Mini Plans

Tug Hill Commission staff attended the Osceola Town Board meeting this past Wednesday, December 14 and presented a draft mini-comprehensive plan which the town board may adopt as its land use policy document. The comprehensive plan is the central document for a municipality to outline the demographic data, community resources, natural resources, and goals for a town or village moving forward. The comprehensive plan may also be the basis for zoning laws and can provide explanation for how the zoning laws are set up. The Osceola Town Board is set to review the plan for next month's board meeting.

The commission will attend the Harrisburg Town Board meeting on December 20 to present their mini-comprehensive plan.

Technical and Issue Paper Updates

Tug Hill Aquifer 101 For Local Communities

The Tug Hill Commission recently updated the issue paper, *Tug Hill Aquifer 101 For Local Communities*. Updates to the issue paper reflect a final report on the Northern and Central portions of the Tug Hill Aquifer, completed by the United States Geological Survey (USGS). The report, entitled "*Geohydrology and Water Quality of the Northern and Central Parts of the Tug Hill Glacial Aquifer System, Jefferson and Oswego Counties, North-Central New York*", was completed in 2022 and can be found on the USGS website by clicking here. The updated issue paper includes information on Tug Hill Aquifer history, water quality, water usage, geohydrology, aquifer recharge and discharge modeling, and potential future research. Check out Tug Hill Aquifer 101 for Local Communities to learn how the aquifer supplies clean water to our region and its people, and how long-term threats could affect it.

Open Burning Regulations in New York

Remember that burning household trash is illegal in New York and harmful to you and the environment due to the chemicals found in modern day household items! NYS law also prohibits burning leaves at any time and having open fires from March 16 to May 14 annually. Winter Outdoor Recreation Opportunities

Winter Solstice Forest Celebration, December 21, 2022, 7:00 p.m. - 8:30 p.m.

Celebrate the year's longest night, and the return of longer days with Tug Hill Tomorrow at the Joseph A. Blake Wildlife Sanctuary near Watertown on the 2022 winter solstice. Participants will share traditions of solstice celebrations around the world, take a quiet candlelit forest trail walk, listen to a solstice story and create a take-home nature offering. Hemlock Woolly Adelgid Survey Training, December 29, 2022, 10:00 a.m. - 12:00 p.m.

Join a guided walk at the Salmon River Falls Unique Area and learn to recognize and report Hemlock Woolly Adelgid HWA (or the lack thereof) – an invasive insect that kills hemlock trees. The Eastern Hemlock is a key tree species found throughout Tug Hill that provides many benefits for people and nature. Detecting the presence of HWA early on provides enough time to protect infested trees and helps to stop the spread to new areas. Trainers will help participants learn how to identify the Eastern Hemlock, survey for HWA and report observations using their smartphone through a free mobile application called iMapinvasives. Oneida County DPW Plow Trucks Go Green



Oneida County Department of Public Works plow trucks are now using green flashing lights as part of a pilot program to increase visibility and safety on winter roadways.

The Oneida County pilot program was initiated after New York State passed Assembly Bill A811A during the 2021-2022 legislative session, which allowed for the use of green lights, or alternating green and amber lights, on municipal vehicles being used for snow removal. The law currently applies only to municipalities and not to privately-owned vehicles.

Some of the DPW's 25 plow trucks have already been outfitted with the flashing green lights and have been out on snow removal duty. The rest of the county fleet should have them installed by the end of December.
