Tug Hill Sages Class of 2023 Nominations Open

As part of the NYS Tug Hill Commission 50th anniversary celebration, we are seeking nominations for Tug Hill Sages. Since 1983, the distinction of "Tug Hill Sage" has been bestowed upon local individuals who have demonstrated a lifelong commitment to the region through leadership, civic involvement, and community service – or individuals who have otherwise directly contributed to improving the quality of life for those on the Hill. Sages also have a deep knowledge of the Tug Hill Region's heritage, culture, and environment. To date, 36 individuals have been recognized for their contributions to the region.

The commission will be accepting nomination forms from June 1 to August 15, 2023. Sage nominees will be reviewed and selected by the Tug Hill Commission board based on the information provided in the form and adherence to the nomination criteria. The newest round of Tug Hill Sages will be selected in



September and announced at the commission's 50th anniversary celebration October 19 at Tailwater Lodge.

Jefferson County Awarded \$8.5 Million Restore NY Grant to Improve Deferiet Mill Site

Jefferson County was among four Restore NY 'special projects' winners statewide this round. Special projects are awarded to municipalities where a highly visible and blighted property causes severe economic injury and has a depressing effect on the overall economic development potential of the community. Jefferson County will receive over \$8.5 million for demolition of the former St. Regis paper mill in the village of Deferiet.

Commission staff assisted Jefferson County to submit a Restore NY Round 7 application in February for the "Reinvent Deferiet

Initiative: Mill Site Demolition Project." The project will demolish the century old, abandoned former St. Regis paper mill facility in the village of Deferiet and town of Wilna. The site includes 192 acres of land, 15 buildings, ancillary structures, foundations, and debris piles.

Amid tax delinquency, liability concerns, and the extent of demolition activities required, there has been no private party able to successfully return the site to productive uses. However, a partnership that includes the village of Deferiet, the town of Wilna, Jefferson County Economic Development, Jefferson County, the Tug Hill Commission, NYS Department of State (DOS), and the NYS Energy Research and Development Authority (NYSERDA) is working together to study and address existing site conditions with the goal to create multiple community-informed projects involving renewable energy, light-industrial/commercial redevelopment, and restoration of habitat.

Other programs are part of the same effort. NYSERDA Build-Ready program is assessing part of the site for solar development. Also, Wilna is working with stakeholders as it begins a DOS Brownfield Opportunity Area study for the site. An application to the National Grid Brownfield Redevelopment program is also pending.

Highway Departments and Town Budgets Workshop Information Available

Approximately 40 town supervisors and highway superintendents packed the Adams municipal building on Tuesday, May 30 for the "Highway Departments and Town Budgets Workshop" presented by Laird Petrie. Tuesday's presentation discussed the duties and responsibilities of the highway superintendent and the town board as they relate to budgets, highway funds, hiring personnel, and purchasing of highway equipment and materials. Lewis County Cemetery Workshop Well-Attended

On Friday, May 19 the Lewis County Historical Society hosted a two-day Lewis County Cemetery Workshop in Lowville. This free workshop was the result of a partnership between the Lewis County Historical Society, the NYS Division of Cemeteries, the Lowville Rural Cemetery Association, and the NYS Tug Hill Commission, which provided hybrid online options for those who could not attend the workshop in person.

Introductory remarks were made by Jonathan Miller, President of the Lewis County Historical Society, and Peter Hayes of the Constableville Cemetery Board. Each presentation was an open forum for attendees to pose questions to these experts in order to help address the chal-



lenges faced by municipal officials, cemetery boards, and those interested in historic preservation. The presentations were as follows: "Abandoned Cemeteries and Municipal Responsibilities," with David Fleming, COO of Featherstonhaugh, Wiley, and Clyne, LLP, as a follow-up to the recently-updated *NYS Tug Hill Commission Technical and Issue Paper* by the <u>same name</u>; "Cemetery Basics," with Cynthia Craig, a licensed funeral director and vestigator for the NYS Division of Cemeteries; and "Historic Cemetery Preservation" with Joe Ferrannini of Grave Stone Matters, a professional cemetery conservator. Joe Ferrannini also led the second-day proceedings where workshop attendees were trained in practical preservation techniques at the Lowville Rural Cemetery.

Day one attendees included approximately 40 in-person participants and 72 online viewers.

North County Clean Energy Hub Launches

Do you have questions about weatherization and clean energy projects or how you could help pay for them? The North Country Clean Energy Hub recently launched, with staff prepared to offer a variety of information on such resources to North Country residents. The mission of the hub is to "support people and businesses in adopting clean energy technology, utilizing energy efficiency programs, and finding jobs in the clean energy industry. These initiatives can save money, make homes healthier, and reduce reliance on fossil fuels." The hub will serve Clinton, Essex, Franklin, St. Lawrence, Hamilton, Jefferson, and Lewis counties.

The hub offers advisory resources that can help residents and homeowners access funding, information, and contractors. The advisory topics include home energy audits, weatherization and energy efficiency, green heating and cooling options, and renewable energy. Depending on your family's income and the improvements you are interested in, you may be eligible for grants, loans, rebates, and tax credits.

As clean energy efforts expand in New York, the hub is seeking to provide workforce development support to ensure that there is an adequate pool of companies and skilled labor to meet the demand of clean energy projects. Contractors or those looking to enter the clean energy industry should reach out.

DEC Announces "Regenerate NY" Forestry Cost Share Grants

The New York State Department of Conservation (DEC) has announced that \$850,000 in funding is now available for the third round of the "Regenerate NY" Forestry Cost Share grant program. The purpose of this grant program is to assist private landowners to support the regeneration of forests so they may continue to deliver vital services such as providing wildlife habitat, mitigating climate change, protecting air and water quality, and supporting the economy.

Regenerate NY is funded by New York State's Environmental Protection Fund (EPF) and managed by DEC's Division of Lands and Forests. Private landowners planning to restore or establish five or more acres of forest land in New York State may apply for grant awards ranging from a minimum of \$10,000 to a maximum of \$100,000, with a required 25 percent match. Regenerate NY is a cost share reimbursement program, so applicants would pay the costs upfront and be reimbursed 75% of the costs.

Eligible projects include: tree planting, soil scarification, removing competing vegetation that would interfere with seed-ling establishment and growth, and installation of deer fence.

Applicants must work with a forester or a qualified natural resource professional to develop their project. Up to two applications may be submitted per applicant, provided the applications are for separate properties.

Applications can be submitted through the <u>NYS Grants Gateway</u> and will be accepted until 5:00 p.m. on October 6, 2023, or until funds are depleted, whichever comes first. Grants will be awarded on a rolling basis. For more information visit the <u>DEC's</u> <u>website</u>.

DEC experts will talk about the current state of Lake Ontario sport fisheries and take questions on a wide array of management actions and research taking place on the lake and tributaries. Wastewater Collection System Maintenance Webinar June 13

The Environmental Finance Center Network, in cooperation with the Environmental Finance Center at Syracuse University and the Great Lakes Environmental Infrastructure Center, is hosting a one hour webinar on Tuesday, June 13 at 1:00 p.m. Presenter and wastewater trainer, Gary Pearson, will will discuss recommended routine maintenance tasks for wastewater collection systems, including:

- Methods for cleaning sewer collection mains
- How smoke testing is conducted and interpreted
- Flow testing procedures for collection system mains
- Methods used to conduct condition assessment mains
- · Defining flow and filtration in collection systems
- Methods for assessing lift stations & diagnose operational issues
- And more!



The webinar is geared for managers, owners, and operators of wastewater systems with an average daily flow of less than one million gallons, decision-makers for wastewater utilities, including mayors, finance officers, utility managers, public works directors, city councilors, board members, and clerks, as well as consultants and technical assistance providers serving wastewater systems.
