CTHC Fall Meeting Held

On Thursday, September 21, the Cooperative Tug Hill Council (CTHC) held their annual fall meeting at the Steak and Brew Restaurant in Turin. Thirteen of the 22 CTHC towns and villages were present, along with six Tug Hill Commission board and staff, members, as well as several other guests. Following approval of the previous meeting's minutes and the most recent financial report, Chairman Roger Tibbetts presented the proposed 2024 budget with no increase from 2023. He also gave a budget projection which showed that dues should remain at current levels for several years. The proposed budget was approved.

The evening's speaker was Candy Akin, director of the Lewis County Real Property office, describing the services they provide and the assistance they give to the assessors working in the Lewis County municipalities. The presentation on the amount of assistance the real property office provides was eye-opening for many attendees. Commission Executive Director Katie Malinowski also gave a report on the results of the commission's 2023 local leaders survey, presented a draft of their amended outside region policy, and provided updates on several pieces of legislation they have been working on at the behest of the Tug Hill communities, including the minimum maintenance roads legislation for the town of Lorraine. Finally, the attendees were updated on several planning projects that commission staff is working on in CTHC.

Circuit Rider Angie Kimball spoke about interest from several more communities to join the Cooperative Zoning Board of Appeals (ZBA) and that options to either increase the size of the ZBA or split into two boards are being investigated. Concerns about increasing vacancies in elected and appointed offices were discussed, with Osceola Town Supervisor Fran Yerdon leading a discussion on how to make more people aware of vacancies and get more people involved.

Traffic Safety Coordinator

The Tug Hill Commission has received grant funding, through the Governor's Traffic Safety Committee (GTSC), to fund a part-time traffic safety coordinator (TSC) beginning on October 1, 2023. The TSC will assist communities within the four-county region in the form of community outreach and education, assistance with grant opportunities, conducting digital and physical data analysis on roadways, and providing assistance with the Metrocount traffic counter upon request. The position will also serve as a liaison between NYS Department of Transportation and highway departments, county traffic safety boards, local law enforcement agencies, GTSC, and local municipalities to address traffic safety concerns within communities. The TSC will serve municipalities by focusing on decreasing traffic related incidents while enhancing the safety and well-being of community residents.

Rodman Comprehensive Plan SWOT Exercise

The town of Rodman Comprehensive Plan Committee held a "Strengths, Weaknesses, Opportunities and Threats" (SWOT) session on September 26 as part of their comprehensive plan update. The session, led by Tug Hill staff Matt Johnson, Christopher Barboza, Gabriel Yerdon, and Fort Drum intern Kaitlyn Valdez, targeted the input of planning board members, comprehensive plan committee members, and local residents. About 21 town residents (including board members) attended the session and provided valuable input.



A SWOT is a type of visioning exercise which

helps gather thoughts and opinions about a community's future. All comments will be compiled into a summary for the plan committee to review. Any relevant questions or concerns heard at the SWOT will be incorporated into a community survey to be sent out in the coming weeks.

Black River Trash Bash Clean-Up

On September 13, members of the Jefferson County Water Quality Coordinating Committee participated in the Black River Trash Bash, an event held to raise awareness about the impact of trash and plastic pollution on water quality and the environment. The event was held at Jefferson County's Day Use Area in Felts Mills, NY. The reforestation property is about 292 acres in size with Felts Mills Creek, a tributary to the nearby Black River, running through it. About 60 pounds of litter was collected, which filled eight garbage bags. Thanks to White's Lumber in Watertown for their donation of work gloves for the cleanup. Thanks also to Channel 7 News for covering the story and North Country Public Radio for covering this important event. The Lewis County WQCC held their event on September 26, and the Adirondack Communities Advisory League will be cleaning at Hawkinsville Dam on October 7. Tug Hill Traverse Concludes 2023 Trail Work

Core volunteers for the Tug Hill Traverse Trail recently enjoyed a picnic at the Tug Hill Wildlife Management Area in Montague, Lewis County to acknowledge the end of the 2023 trail maintenance and construction season. Tug Hill Tomorrow Land Trust has partnered for several years with the Black River Chapter of the Adirondack Mountain Club to establish this historic 20-mile north/south hiking trail through the heart of Tug Hill. When complete, the Tug Hill Traverse Trail will extend from the DEC's Tug Hill Wildlife Management Area on the north to the West Leyden Osceola Rd on the south, and generally follows the East Branch of Fish Creek. Interim trailheads are located on the G&W and Michigan Mills roads, respectively.

Salmon River Fish Hatchery Open House Well-Attended

On September 23, the NYS Department of Environmental Conservation (DEC) successfully hosted its 24th annual Salmon River Fish Hatchery Open House and Family Day in Altmar. For the first time since the COVID-19 pandemic, the Salmon River Fish Hatchery was packed in celebration of National Hunting and Fishing Day.

The Salmon River Fish Hatchery's visitor center was filled with information tables and displays by conservation organizations, fishing and hunting clubs, outdoor recreation groups, and some state and federal entities to help people learn more about the Salmon River Corridor and the Lake Ontario ecosystem. Various native salmon, trout, and sturgeon species were at the forefront of these presentations. Special attention was paid to rare and threatened fish species in New York, and DEC staff also raised awareness for some invasive species. Visitors to the hatchery were welcomed to join guided tours of the facility, including behind-the-scenes insight on how the hatchery helps bolster the world-class salmon and trout fisheries in Lake Ontario and its tributaries, including the eponymous Salmon River.

The Tug Hill Commission was present among the tabling organizations, engaging with visitors, offering free Tug Hill Recreation Guides (also available online at www.visittughill.com), and encouraging passersby to test their regional knowledge with the commission's trivia wheel.


What are some of your favorite hobbies?

I had ideas on what I wanted to do with my life, but my time in the military has shown me that I want to work in a profession where I can be down on the ground, seeing changes happen, and be involved in the process.

What projects are you working on for the Tug Hill Commission?

I'm currently working on updates to the resource management plan for the RACOG area. I may also work on walkability for the interested communities in RACOG.

Why are your projects at the Tug Hill Commission important?

Helping to bring out the potential of the area is a huge thing. My projects involve working with census data, which is interesting. I've noticed that the population in the region is declining, which is sad and surprising to me: personally, I really like this area, the snow, the seasons.

What do you enjoy most about working at the Tug Hill Commission so far?

Everyone who works here is very committed and passionate about what they're doing. I also really like that the commission is non-regulatory and works by request to help communities. It can be harder for rural communities to find the same resources as larger areas, so helping to do that is important.

What are some of the challenges with your internship and how do you solve them?

Really, the biggest challenge is that this is such a new experience: I just have to do it and keep going. It's a big shift going from a military to an office setting, but I'm starting to settle in more.

What is in store for you after your internship with THC?

After my internship, I plan to go back to school to explore possibilities and find something that is the best fit for me but is also a good fit for whatever job market my husband and I decide to settle down in. In the past, I was interested in environmental science, but I am also interested in exploring urban planning or architecture.

Stormwater and Floodplain Trainings in Oneida County

Two training opportunities will be offered by the Herkimer-Oneida Counties Comprehensive Planning Program (HOCCPP) and presented by the New York State Department of Environmental Conservation.
