## Infrastructure Funding Roundtable Well Received

Forty-five people participated in the November 9 Infrastructure Funding Roundtable workshop held at the Jefferson Lewis BO-CES Howard G. Sackett Technical Center. During the event, sponsored by the Syracuse University Environmental Finance Center, River Area Council of Governments, Tug Hill Commission, and Lewis County Planning, participants were able to learn about funding opportunities for safe and clean water management and other community investments from state and federal agency representatives. Presentations and consultations were done by the NYS Department of Health, Environmental Facilities Corporation, NYS Department of Environmental Conservation, NYS Homes and Community Renewal, NYS Department of State, and USDA Rural Development.

After lunch provided by the Howard G. Sackett Technical Center culinary class, individual consultations with funders were available to address specific project funding questions and needs. Additionally, attendees got a first look at a new quick guide for town boards on special district formation developed in partnership with the NYS Tug Hill Commission, available here.



## **Tug Hill Staff Share Community Solar Perspective**

Commission staffers Katie Malinowski, Matt Johnson, and Matthew Smith presented "A Community Perspective on Solar" last week to a group of over 65 people across New York, Pennsylvania and Ohio. The presentation was part of a continued collaboration between Cornell Cooperative Extension, Pennsylvania, and Farm Bureaus of Ohio, Pennsylvania, and New York providing a series of webinars to explore the continued push for development of solar energy projects in agricultural areas of the Northeast. The five part series addressed the topic from multiple perspectives and helped to identify the opportunities and

### Wind Farm Open House Held in Worth

SWEB Development hosted an open house on their proposed Worth Wind Energy Project on Tuesday November 14. As currently configured, the facility would have a total capacity of up to 92 MW with turbines with a nameplate capacity between 4.5 MW and 7 MW. The project has completed its feasibility study with the NY Independent System Operator (NYISO), and is now completing a system impact study with the NYISO.

A MET tower and LiDAR were installed in June 2022, with the LiDAR decommissioned in the summer of 2023. The MET tower continues to collect data to gain a better understanding of wind speed and directional seasonality. SWEB has contracted with Stantec for field work and environmental data collection. So far, Stantec has completed grassland breeding bird, marsh bird, and forest nesting raptor surveys, a wetland and watercourse survey, and a bat presence-absence survey. Eagle point count and winter grassland raptor surveys are underway, as well as a Phase 1A cultural resources analysis.

SWEB plans to permit this project through the Office of Renewable Siting (ORES) 94-c process.

### **Consolidated Funding Application Awards Announced**

Several Tug Hill communities and organizations will be receiving state funding for recreation related projects, as announced earlier this week:

- The town of Wilna will receive \$285,000 to begin development of the Herrings Waterfront Park at the former Crown Cleaners site. The goal is to transform the property from a former environmentally contaminated industrial site into a recreational area for the community.
- The village of Lowville will receive \$500,000 to revitalize their Veterans Memorial Park by installing accessible walkways, green infrastructure improvements, and enhanced amenities to create a vibrant, accessible space for community gatherings, cultural programs, and safe recreational activities, fostering regional economic growth and community revitalization.
- The village of Pulaski will receive \$67,500 for design and engineering needed to upgrade the recreational facilities at Dunbar Park, connecting it to the Haldane Center with a pedestrian bridge on the Salmon River Greenway.
- The Winona Forest Recreation Association (Jefferson and Oswego Counties) will receive \$239,405 to purchase a snowmobile trail groomer to maintain snowmobile trails and enhance winter outdoor recreation.
- The Osceola Snowmobile Association Inc. (Lewis County) will receive \$30,646 to purchase a snowmobile drag for trail
  grooming.
- The Trailbusters Snowmobile Club (Oneida County) will receive \$69,121 to purchase two new groomer drags designed for low snow and warmer temperatures and acquire a dump trailer for year-round maintenance and equipment transportation.

# Preservation Assistance Grants for Smaller Institutions Available

On Friday, October 17, the Division of Preservation and Access under the National Endowment for the Humanities (NEH) started accepting applications for its Preservation Assistance Grants (PAG) for Smaller Institutions program.

What does this program fund? This program aims to help small and mid-sized organizations preserve and manage humanities collections and to secure their integrity and significance to a wide audience. Funded activities under PAG include: preservation assessments; consultation with preservation and conservation professionals, source communities, and scholars; development or revision of plans, policies, and manuals; purchase of preservation supplies and equipment; purchase of environmental monitoring equipment; preparatory steps in the description of collections; education and training for staff in small and mid-sized organizations; and disaster planning and preparedness. Conservation treatment and digitization, however, are **not** eligible activities.

Who should apply? Eligible organizations include: nonprofits (501©3 IRS status), state governments, public and state-controlled institutions of higher education, and local and county governments.

### **Companion Animal Projects Grants Due January 29**

The NYS Department of Agriculture & Markets has two grant funding rounds available now through the Grants Gateway for capital projects necessary for the secure containment, health and adequate care of sheltered dogs and cats. For purposes of this program, a project may be a portion of a larger overall capital project. Eligible expenses include direct costs related to the: construction, renovation, rehabilitation, installation, acquisition, or expansion of buildings, equipment or facilities. Applicants will need to provide a minimum of ten percent (10%) of the total project costs. RFP0311 is for pounds, shelters, humane societies, or rescue facilities that are operated by or under contract with one or more municipalities for the provision of pound or shelter services. RFP0312 is for not-for-profit pounds, shelters, humane societies, or rescue facilities that are NOT under contract with one or more municipalities for the provision of pound or shelter services. The deadline for both grant applications is January 29, 2024.

### **Urban and Community Forestry Grants Due January 31**

Applications are now open for a total of \$12.9 million for urban and community forestry projects through the NYS Department of Environmental Conservation. The funding was made available by the U.S. Department of Agriculture Forest Service's Urban

and Community Forestry Program to increase equitable access to healthy trees and green spaces in urban and community forests to support building a clean energy economy, advance environmental justice, and create economic opportunity.

Applicants may apply for funding under two categories: Community Forest Management Plan Implementation (\$10 million) and Ash Tree Management (\$2.9 million). The maximum request is \$500,000 per application and no match is required. All projects must take place in disadvantaged communities as identified by any of three federal and state tools listed in the request for applications. See the map below for eligible communities in the Tug Hill region. Applications are open now and the deadline to submit applications is Wednesday, Jan. 31, 2024.

DEC's Urban and Community Forestry pro-

### **Energy Advisors Available to Tug Hill Residents**

To help New Yorkers access and navigate opportunities to increase their energy efficiency and save money while adapting to the changing energy economy, the New York State Energy Research & Development Authority (NYSERDA) created Regional Clean Energy Hubs. Clean Energy Hubs connect people to the clean energy economy through energy advisors.

Energy advisors are available to residents and small business owners to assist with navigating NYS and federal funding opportunities and identifying optimal energy saving solutions on an individual basis. Energy advisors and their regional energy hubs can:

- Assist with accessing job training and employment in the clean energy sector
- Discuss a home energy assessment and why it would be useful
- Help someone fill out an application for a free home-energy assessment
- Show what types of energy incentives a person or business may qualify for
- Share information about electric vehicles (EV), charging stations, even help someone file an EV rebate
- Find a qualified contractor to perform clean energy upgrades
- Locate a community solar program and help residents and businesses sign up for it.
