Lowville Receives DRI Grant

The North Country Regional Economic Development Council announced its winners of the Downtown Revitalization Initiative (DRI) and NY Forward this week, and the village of Lowville is the recipient of a \$10 million DRI award – congratulations!

In the DRI application, Lowville's vision is described as "Downtown Lowville is a vibrant, rural community destination for the region. It is committed to maintaining a high quality of life, promoting environmental sustainability, and providing unparalleled access to outdoor recreational opportunities. The Village intends to preserve and enhance its small-town charm while diversifying its economic base and encouraging economic development consistent with its unique character. With the creation of an active and walkable commercial corridor, the opening of new and niche businesses, the expansion of downtown housing options, and the enhancement of recreational and quality-of-life amenities, the Village sees itself transforming into a family-friendly and economically viable place for people of all ages to live, work, and visit."

RACOG Board Meeting Recap

The River Area Council of Governments (RACOG) held their first board meeting of 2024 on January 24. Officers for 2024 were elected, with Paul Smith, the town of Wilna supervisor, voted in as the new chairperson and Yvonne Boliver, a board member for the town of Croghan, voted in as vice chairperson. RACOG also voted to admit the town of Watson to their council of governments

Amber Swan was introduced to the RACOG board as their new associate circuit rider. She is originally from the Carthage area, but now lives in Watertown. The board approved their 2024 budget and approved bronze sponsorship of the May 1-2 Tug Hill Local Government Conference. Additionally, the board approved holding the RACOG Economic Visioning Summit at the Carthage Elks Lodge on April 25.

NorCOG and Economic Study Updates

The North Shore Council of Governments (NorCOG) met on Wednesday, January 17. The two major agenda items requiring attention were the election of officers for 2024, and authorization of COG sponsorship as in past years of the Tug Hill Local Government Conference. Following that, the NorCOG economic study steering committee met to review the high points of the draft final study, available on the NorCOG website, under Projects and Reports.


Extensive discussion followed on both the draft and additional aspects that the group identified as important. Tracy Verrier of the MRB Group noted the topics discussed and will be doing additional work to augment the draft study, which will be presented to the public on January 30, at 7:00 p.m. at A.A. Cole Elementary School, 1683 State Route 49, Constantia. The upcoming meeting has been mentioned at the January municipal board meetings of member communities, and NorCOG encourages everyone interested in the study to attend next Tuesday's meeting.

Denmark Solar Array

The town of Denmark accepted a proposal from Fourth Coast Inc., Clayton to install a 78.9 KW roof mounted solar array at their December board meeting. Once installed, the solar panels will generate 100% of the town's projected municipal electrical needs through 2049. The town's electric bill has been steady climbing, with a 48.2% increase in costs for electricity in 2022 with 5000 KW less usage than 2021. The town is on pace for a 28.7% increase in its electric bill in 2023, with a continued decrease in power usage.

The quoted installed price of the project is \$244,000. The town has been approved for a NYSERDA NY-Sun incentive award of \$27,355. In 2024 the town will apply for a federal Inflation Reduction Act "direct pay" rebate in the amount of \$65,264 to be received in 2025. In total, 38% of the projected cost is funded through grants. After grants, the final cost of the project is expected to be \$151,381, with a little over six year payback period for town taxpayers. The town will utilize the American Rescue Plan Act (ARPA) funds of \$118,126 and fund balance to cover the remaining \$33,255.

The project is estimated to save taxpayers more than \$736,000 over the 25-year life of the project. The solar array is expected to be producing power by August 1, 2024. It will eliminate power costs for 25 years. Municipalities can contact the Tug Hill Commission for technical assistance on similar projects.

West Monroe Route 49 Study Funding

The Syracuse Metropolitan Transportation Council has published a draft of their 2024-2025 Unified Planning Work Program, which includes a proposal sponsored by West Monroe for a Route 49 Corridor study. The project "will address transportation needs of the area residents and commuters, adequacy, safety, and ease of use, existing transportation infrastructure, access management, and a traffic safety analysis." The study is slated to begin in the first quarter of the state fiscal year 2024-2025, and a final document is proposed to be presented in the second quarter of state fiscal year 2025-2026. There are many steps to the project and public engagement is envisioned as part of the process. As of right now, this is a draft document and is subject to change. Public comments on this document will be taken through February 21, 2024.

Wilna, Carthage, and Deferiet Hold SWOT for Comprehensive Plan Update

The town of Wilna, and the Villages of Carthage and Deferiet's comprehensive plan committee held a "Strengths, Weaknesses, Opportunities and Threats" (SWOT) session for the general public on January 23, 2024, as part of the comprehensive plan update. The session, led by Tug Hill staff Christopher Barboza and Mickey Dietrich, along with RACOG associate circuit rider Amber Swan, targeted the input of planning board members, comprehensive plan committee members, town and village board members, and local residents. About 15 town residents (including board/committee members) attended the session and provided valuable input.

A SWOT is a type of visioning exercise which helps gather thoughts and opinions about the town's future. All comments will be compiled into a summary for the plan committee to review. Any relevant questions or concerns heard at the SWOT will be incorporated into a community survey to be sent out in the coming weeks.



NYS Department of Environmental **Conservation Regional Wildlife Program** Manager Paul Jensen will share results of recent research on and discuss the potential for martens to recolonize the Tug Hill region. He will also provide an overview of the Adirondack Inventory & Monitoring (AIM) Network - a collaborative survey effort involving the deployment of camera traps by several regional partners in northern New York, which will contribute to our understanding of marten and other wildlife populations in this region, including the use of important landscape linkages between the Adirondacks and Tug Hill.

Naturally Lewis 2024 Grants Programs

The Lewis County Development Corporation's Community Economic Development Program recently announced four grant programs available in 2024. A total of \$930,000 will be made available, with program applications opening throughout 2024.

Small Things, Big Impacts

- Eligible: Businesses and Non-profit Organizations
- Focus areas: Enhancing their visibility through creative means in the community
- Grant awards: \$500 to \$1000 per grant
- Applications open: January 15, 2024
- Quarter 1 deadline: March 28, 2024 (Applications accepted on a quarterly basis until funds are dispersed)

Community Connections Fund

- Eligible: 501©3 non-profit organizations, municipalities, and schools
- Focus areas: The program or project must strengthen ties within the community, to develop relationships, and to spur economic growth and development through the creation and enhancement of public gathering places
- Grant awards: Two \$30,000 awards OR one \$60,000 award
- Applications open: April 1, 2024
- Application deadline: June 13, 2024
- Grants determined: July 2024

NBRC Grant Info Sessions February 5 and February 9

The Northern Border Regional Commission (NBRC) is holding two information sessions in February, one on general eligibility for its three open grant rounds and another specifically on the Catalyst program. The February 5, 1:00 p.m. to 2:30 p.m. session will provide an overview of NBRC funding requirements such as applicant eligibility, NBRC eligible counties, timeline, and important dates along with a brief overview of each of the three programs that have announced funding in 2024 – Catalyst, Forest Economy, and Timber for Transit. The program overviews will highlight the core focus areas of the programs, differences between the programs, and immediate next steps for interested applicants. Registration required, register here.

The February 9, 10:00 a.m. to 11:30 a.m., session will provide a more in-depth presentation of the Catalyst Program including changes in 2024, review of eligible project purposes, award sizes, pre-application process, evaluation of pre-applications, and NBRC and state program priorities for 2024. The goal is for participants to leave these sessions with the information needed to prepare for the pre-application phase. Registration required, register here.

Broadband Municipal Infrastructure Program Webinar February 1

Empire State Development's ConnectALL office has launched the Municipal Infrastructure Program with \$228 million to support the construction of new fiber for tens of thousands of homes statewide. Priority will be given to unserved and underserved locations. There will be an information session on **Thursday**, **February 1 from 1:00 p.m.- 2:30 p.m.** Click here to register.

The Municipal Infrastructure Program will provide grants for open-access broadband infrastructure that is predominantly publicly controlled. The last mile fiber deployments will connect homes to reliable high-speed internet service. The program will facilitate a variety of models of municipal broadband and public-private partnerships. Eligible public entities, Tribal Nations, municipal utilities, and utility cooperatives can partner with private partners like ISPs, MSPs, and broadband infrastructure builders and owners. 2024-2025 Records Management Grant

The New York State Archives has announced that they are now accepting applications for the 2024-2025 Local Government Records Management Improvement Fund (LGRMIF) grant cycle.

The Local Government Records Management Improvement Fund provides grants to local governments. These grants assist local governments to establish records management programs or develop new program components. It is a competitive program, awarding grants based on the merits of applications.

If you plan to apply for an LGRMIF grant, your Records Management Officer (RMO) must have a NYS Directory Service (NYSDS) account by **February 26, 2024**. If you do not have a NYSDS account, please complete the **online registration form**.

The 2024-2025 application due date will be **March 11, 2024, at 5 p.m**. For more information, and to access the guidelines, please visit the **LGRMIF webpage**. NYS DEC Wetlands Webinar February 1

The Hudson River Estuary Program is hosting a webinar on Thursday, February 1, from 1:00-2:30 p.m. with Krista Spohr from the NYS Department of Environmental Conservation (DEC). She will provide an overview of NY's current freshwater wetlands regulations, how they are enforced, and explain forthcoming regulatory changes and their effective dates.

Revisions to New York's Freshwater Wetlands Act were made in 2022. Currently, DEC's jurisdiction is limited to wetlands that are equal to or greater than 12.4 acres (and certain wetlands of unusual local importance) and identified on the state's freshwater wetlands map. The new legislation will eliminate the map requirement beginning in 2025, and in 2028 DEC's jurisdiction will expand to wetlands as small as 7.4 acres. The reforms will allow DEC to protect over one million acres of critically important freshwater wetlands that are currently unmapped and thousands of additional acres of smaller wetlands.

Freshwater Wetland Regulations Input Now

Earlier this month, DEC published an <u>advanced notice (PDF)</u> of proposed rulemaking, inviting public comment on potential updates to freshwater wetlands protection and classification regulations.

The DEC is looking for answers to specific questions as well as general input and suggestions which may inform the potential revisions, including:

- criteria for "wetlands of unusual importance" including significant flooding, rare animals, vernal pools, and local and regional significance
- · criteria for extension of regulated adjacent areas
- procedures for jurisdictional determination.


