
Board representatives from the North Shore Council of Governments (NorCOG) and the Salmon Rivers Council of Governments (SRCG) have shared growing concerns with their circuit rider about the future of community leadership. Participation on town and village boards has steadily declined, and many students graduate without understanding how local government works or how they can get involved. The discussion emphasized engaging students early: building civic awareness, developing leadership skills, and fostering a pipeline of future board members, clerks, and civic leaders. Strengthening relationships between towns, villages, and school districts was highlighted as a key strategy for closing knowledge gaps and ensuring stronger local governments in the years ahead.

Superintendents also learned about programs that could be supported by NorCOG and SRCG, including the NYS Seal of Civic Readiness and the Civic Service Student Activity Program (CSSAP), which offer students opportunities to gain real-world local government experience. The group discussed ways to incorporate these programs into existing curricula and extracurricular activities, with the shared goal of inspiring the next generation of civic leaders while benefiting the communities they serve.

Animal Shelters Issue Paper Updated

The commission has updated its recently released *Understanding the New Regulatory Standards for Animal Shelters* issue paper to incorporate feedback from the NYS Department of Agriculture and Markets and local dog control officers. The revision also includes a gap analysis tool to help municipalities identify and address potential challenges posed by the new regulations. The updated paper is available here for download.

August 20 Companion Animal Care Standards and Capital Fund Webinar

Join NYCOM and presenter, Libby Post, executive director of the New York State Animal Protection Federation, for an informative and practical session on how your municipality can prepare for the implementation of the Companion Animal Care Standards Act, which takes effect on December 15, 2025.

This new law establishes minimum standards of care for shelter animals and will require many municipal shelters to evaluate, and potentially upgrade, their existing policies, procedures, and facilities. The webinar will also provide a detailed overview of the Companion Animal Capital Fund, a state funding source that can help offset the costs of capital improvements at municipal shelters.

This hour-long webinar starts at noon on Wednesday, August 20, and is provided at no cost to NYCOM members, although registration is required. A recording of the webinar will be provided to registrants following completion of the webinar.

Oneida County Agricultural Strategic Plan Released

Oneida County has released its 2025-2030 <u>Agricultural Strategic Plan</u>, designed to provide stakeholders in Oneida County's agricultural sector with a roadmap to guide future investments and advance the county's agricultural economy. It builds upon previous plans and also serves as a strategic evaluation of the county's agricultural and food-related initiatives.

During the formation of the plan, five theme areas were identified:

- 1. Farmland Preservation and Protection
- 2. Economic Development and Business Support
- 3. Agritourism and Local Food Promotion
- 4. Workforce Development and Farm Transition
- 5. Sustainability and Climate Resilience

From there, 21 project concepts were identified within the five theme areas. Each concept is outlined by a short profile that details current challenges, a model approach, and key actions.

The plan addresses the Chobani dairy processing plant that is being constructed in Rome, NY. The plant is estimated to process approximately 12 million pounds of milk per day, which represents over 25% of the state's total daily milk production. To prepare for this, the county highlights projects that focus on developing the processing and distribution of agricultural products, enhancing support for farms throughout the supply chain.

The county's goal of preserving existing farmland for continued agricultural operations is also highlighted in the plan. Large-scale solar has recently been competing for farmland, as sighting on flat, cleared land is ideal for both agriculture and solar. Communities are faced with the pressure of balancing residential development, renewable energy goals, and agricultural expansion. With these concerns in mind, the plan highlights projects that encourage local municipalities to update their comprehensive plans and solar laws to include farm-friendly land use regulations.

\$53 Million in Grants Available for Swimming Facilities

Governor Kathy Hochul <u>announced</u> the second round of the New York Statewide Investment in More Swimming (NY SWIMS) Initiative, offering \$53 million in capital grants to municipalities and nonprofits to expand safe swimming access across the state. The program, managed by the Office of Parks, Recreation, and Historic Preservation and administered by the Dormitory Authority of the State of New York, provides matching grants for constructing, renovating, or improving swimming pools and natural swimming areas, with at least \$25 million reserved for underserved communities. Grants range from \$250,000 to \$10 million, requiring a 20% funding match, and can cover related infrastructure like bathhouses, public restrooms, and accessibility features.

Applications will be accepted from September 24 to October 30, 2025. Projects will be prioritized that demonstrate clear public benefit, serve underserved communities, and show strong preparation for implementation. A webinar for potential applicants will be held on September 3, 2025, and application materials are available on <u>DASNY's website</u>.


EFC Grants Due September 12

The Water Infrastructure Improvement (WIIA) program provides competitive grants to help municipalities affordably undertake critical wastewater and drinking water infrastructure projects. The Intermunicipal Water Infrastructure Grants (IMG) program is available for both drinking water and wastewater projects that serve multiple municipalities, such as a shared water quality infrastructure project or the interconnection of multiple municipal water systems. Both grant programs are administered by the Environmental Facilities Corporation (EFC).

EFC uses an online application. Applications are due by 5:00 p.m. on September 12. EFC held a webinar on July 11 to share information about this round and how to apply. A recording is available on YouTube. Any community that needs assistance with its water infrastructure is encouraged to contact our EFC's Community Assistance Teams.

Northern Border Regional Commission Pre-Applications Due August 29

Interested applicants are invited to submit pre-applications to the Northern Border Regional Commission's (NBRC) <u>Catalyst</u>, <u>Forest Economy</u>, and <u>Timber for Transit</u> programs for fall 2025 funding consideration. The required pre-applications can be submitted online through the <u>Grants Management System</u> (GMS).



Wood Products Businesses Technical Assistance Available

The Northern Forest Center has recently announced "Telling Your Forest Story," an online workshop series designed to help wood products businesses better understand and incorporate their wood-origin story into business philosophy and marketing messaging.
