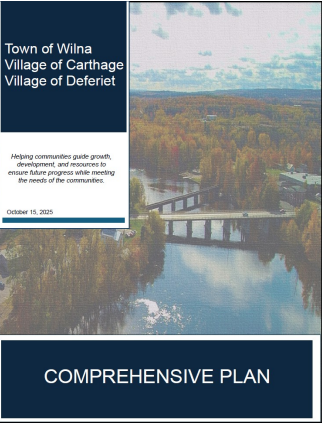


ATV Recreation Workshop January 8

The Tug Hill Commission and Northern Oneida County Council of Governments will hold a workshop on Thursday, January 8, 2026, to present the recently completed paper *ATV Recreation: Considerations for Municipalities*. The workshop will be held at the Boonville Municipal Building, 13149 State Route 12, Boonville at 7 p.m., and will include both a presentation and question and answer session. Commission staff will walk attendees through the content, including the impetus for writing the document, the approach taken to research local laws and relevant court cases, and best practices municipalities may want to consider when opening roads for ATV recreation in their town or village. There will be plenty of time for questions and answers.

Wilna, Carthage and Deferiet Adopt New Joint Comprehensive Plan

The town of Wilna and the villages of Carthage and Deferiet recently adopted their new joint comprehensive plan. Developed by the joint comprehensive plan committee, the document is designed to prioritize capital investments, strengthen local infrastructure, and provide a clear direction for future development. The plan supports the revitalization of village centers, encourages economic growth, and promotes responsible land use and housing development. It will also serve as a framework for zoning, subdivision regulations, and long-term planning decisions to ensure that growth aligns with community goals while preserving local character. The joint planning efforts of the three municipalities reflect a strong regional partnership that focuses on creating vibrant and sustainable communities that future generations can enjoy.

The town of Denmark has adopted its new joint comprehensive plan, developed in partnership with the villages of Castorland and Copenhagen (both fully located within the town) to guide community growth and investment. The villages are expected to formally adopt the plan during their next board meetings in January 2026. The plan will serve as a policy guide that addresses topics such as working lands conservation, transportation, historic preservation, parks and recreation, land use, and community infrastructure. The joint comprehensive plan strengthens regional cooperation and positions the communities in obtaining a well-planned and sustainable future.

OSC Fiscal Oversight Training January 21

The NYS Office of the State Comptroller (OSC) will present “Fiscal Oversight Responsibilities of the Governing Board” on Wednesday, January 21 from 10 a.m. to 11 a.m. online. The governing board’s oversight role can touch virtually every aspect of a local government’s operations. This session will discuss some key functions including budget responsibilities, interim reporting, the audit of claims, and the annual audit requirements. OSC’s staff will also provide resources available to assist in these oversight activities.

Volunteer Fire Infrastructure & Response Equipment (V-FIRE) Grants Due February 25

The V-FIRE grant program is a state-funded \$25,000,000 competitive grant that provides critical funding to strengthen volunteer fire departments and districts statewide. Eligible applicants can apply for up to \$1,000,000 if proposing projects for construction, renovation, or purchase costs for critical facilities (buildings, training facilities, etc.) that support fire operations, or up to \$500,000 if proposing projects for allowable fire service equipment to upgrade and improve their response capabilities. Eligible applicants: volunteer fire companies, municipalities (including fire districts), and counties with municipal shared services projects that have not been funded in a previous round of V-FIRE. The deadline to submit an application is **February 25, 2026**.

Municipal Parks and Recreation Grants Due February 9

\$10 million is available for the second round of the Municipal Parks and Recreation (MPR) grant program to fund the development and improvement of municipal parks and recreation sites. Funding for this program is provided by the Clean Water, Clean Air, and Green Jobs Environmental Bond Act. The MPR grant funding is available for the construction of recreational facilities and other improvements to municipally owned recreational sites and parks. Examples include playgrounds, courts, playing fields, and facilities for swimming, biking, boating, picnicking, hiking, fishing, camping, or other recreational activities. Program guidelines, including how to apply, will be available beginning December 31, 2025, on the [State Parks website](#). The first round of the MPR grant program [awarded](#) \$10 million to 17 projects across the state.

Eligible applicants include counties, cities, towns, and villages within New York State that own the property where the proposed project will take place. Grants will primarily fund construction costs. Preconstruction activities, such as developing plans and design specifications, may be included in the project budget, but the grant cannot fund projects that are solely for planning and design without a construction component. To maximize accessibility to funding, the MPR grant opportunity can fund up to 90 percent of the total eligible project costs, with a matching share requirement of 10 percent. The maximum grant award is \$900,000. Grants are administered on a reimbursement basis. The application period will open on December 31, 2025, and applications must be submitted by February 9, 2026, at 4:00 p.m. Awards are expected to be announced no earlier than May 22, 2026.

Environmental Bond Act Project Tracker

The Clean Water, Clean Air and Green Jobs Environmental Bond Act of 2022 (Bond Act) funds are made available through the sale of general obligation bonds and are being used by NYS agencies and authorities to implement projects that protect water quality, reduce pollution, protect natural resources, help communities adapt to climate change, improve resiliency, and create green jobs.

Bond Act funds support projects in the following categories:

- \$1.5 billion for Climate Change Mitigation
- \$1.1 billion for Restoration and Flood Risk Reduction
- \$650 million for Water Quality Improvement and Resilient Infrastructure
- \$650 million for Open Space Land Conversation and Recreation
- \$300 million for other projects not specifically allocated.
