**Tug Hill Local Government Conference  
Focus on Municipal Challenges and Planning for Growth**

WATERTOWN, NEW YORK - The **NYS Tug Hill Commission** will host the **Tug Hill Local Government Conference** at the **Turning Stone Conference Center**, 5218 Patrick Road, Verona, NY 13478, bringing together local government officials from across the Tug Hill region for two days of education, networking, and professional development.

The conference begins on **Monday, April 20, 2026**, with a special afternoon session titled **“Planning for Growth”** from **1:00 p.m. to 5:00 p.m.** As major developments such as Micron, Chobani, and the Tech Hub drive unprecedented economic growth in the region, this session will explore how towns and villages can adapt land use policies and planning practices to address housing demand, infrastructure needs, and fiscal impacts while strengthening community character.

A **networking reception** will follow on Monday evening from **5:30 to 6:30 p.m.**, offering attendees the opportunity to connect with fellow municipal officials, speakers, exhibitors, sponsors, and agency representatives in a relaxed setting with hors d’oeuvres and a cash bar.

The **full day of training** will take place on **Tuesday, April 21, 2026, from 7:30 a.m. to 4:15 p.m.**, featuring four concurrent session tracks throughout the day. Session topics include land use and SEQR updates, zoning enforcement, clean energy development, procurement and RFPs, litigation avoidance, cybersecurity, artificial intelligence for local government, assessor responsibilities, dog control, sign regulation, rural ambulance services, highway operations and budgeting, and vital records.

Presenters include experienced municipal attorneys, state agency representatives, and practitioners from organizations such as the New York State Tug Hill Commission, New York State Department of State, New York State Department of Agriculture and Markets, the Office of the State Comptroller, the Association of Towns of the State of New York,

county departments, and private law and consulting firms.
